

ASSEMBLY BILL NO. 72—COMMITTEE ON EDUCATION

SUMMARY—Creates the Advisory Committee on the Safety and Well-Being of Teachers. (BDR 34-442)

AN ACT relating to education; creating the Advisory Committee on the Safety and Well-Being of Teachers; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law establishes various requirements governing educational personnel,
2 including requirements governing the licensing, qualifications, employment,
3 powers, duties, supervision and evaluation of such personnel. (Chapter 391 of
4 NRS) **Section 3** of this bill creates the Advisory Committee on the Safety and
5 Well-Being of Teachers, and **section 2** of this bill defines the term “Advisory
6 Committee” to refer to that Advisory Committee. **Section 3** prescribes the
7 membership of the Advisory Committee and establishes procedures governing the
8 operation of the Advisory Committee. **Section 4** of this bill requires the Advisory
9 Committee to review, investigate and make recommendations concerning: (1) any
10 issue relating to the safety and well-being of teachers, including provisions of law
11 or regulations that affect the safety and well-being of teachers; and (2) the
12 consistent implementation of discipline of pupils.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 391 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2, 3 and 4 of this act.

3 **Sec. 2.** *As used in sections 3 and 4 of this act, unless the*
4 *context otherwise requires, “Advisory Committee” means the*



1 *Advisory Committee on the Safety and Well-Being of Teachers*
2 *created by section 3 of this act.*

3 **Sec. 3.** 1. *The Advisory Committee on the Safety and Well-*
4 *Being of Teachers is hereby created within the Department.*

5 2. *The Advisory Committee consists of the following*
6 *members:*

7 (a) *Five licensed teachers who are employed by a school*
8 *district in this State, appointed by the Governor;*

9 (b) *One member of the Senate, appointed by the Majority*
10 *Leader of the Senate;*

11 (c) *One member of the Assembly, appointed by the Speaker of*
12 *the Assembly; and*

13 (d) *The following ex officio members:*

14 (1) *The Superintendent of Public Instruction or his or her*
15 *designee; and*

16 (2) *The Director of the Office for a Safe and Respectful*
17 *Learning Environment appointed pursuant to NRS 388.1323.*

18 3. *After the initial terms, each member appointed pursuant to*
19 *paragraph (a), (b) or (c) of subsection 2 serves for a term of 3*
20 *years and continues in office until his or her successor is*
21 *appointed. Members may be reappointed for additional terms of 3*
22 *years in the same manner as the original appointments. Any*
23 *vacancy occurring in the membership of the Advisory Committee*
24 *must be filled for the remainder of the unexpired term in the same*
25 *manner as the original appointment.*

26 4. *Any legislative member of the Advisory Committee who is*
27 *not a candidate for reelection or who is defeated for reelection*
28 *continues to serve after the general election until the next regular*
29 *or special session of the Legislature convenes.*

30 5. *A majority of the members of the Advisory Committee*
31 *constitutes a quorum for the transaction of business, and a*
32 *majority of a quorum present at any meeting is sufficient for any*
33 *official action taken by the Advisory Committee.*

34 6. *At its first meeting and annually thereafter, the Advisory*
35 *Committee shall elect a Chair from among its members who shall*
36 *serve until the next Chair is elected.*

37 7. *The Advisory Committee shall meet at least once in the*
38 *first calendar year after its creation and thereafter at the call of*
39 *the Chair as frequently as is required to perform its duties.*

40 8. *The members of the Advisory Committee serve without*
41 *compensation and are not entitled to the per diem and travel*
42 *expenses provided for state officers and employees generally.*

43 9. *Any member of the Advisory Committee who is an officer*
44 *or employee of this State or a political subdivision of this State*
45 *must be relieved from his or her duties without loss of regular*



1 *compensation so that he or she may prepare for and attend*
2 *meetings of the Advisory Committee and perform any work*
3 *necessary to carry out the duties of the Advisory Committee in the*
4 *most timely manner practicable. A state agency or political*
5 *subdivision of this State shall not require an officer or employee*
6 *who is a member of the Advisory Committee to:*

7 (a) *Make up the time the member is absent from work to carry*
8 *out his or her duties as a member of the Advisory Committee; or*

9 (b) *Take annual leave or compensatory time for the absence.*

10 **Sec. 4.** *The Advisory Committee shall review, investigate and*
11 *make recommendations to the Legislature, any offices of this State*
12 *and any political subdivisions of this State as may be appropriate*
13 *concerning:*

14 1. *Any issue relating to the safety and well-being of teachers,*
15 *including, without limitation, provisions of law or regulations that*
16 *affect the safety and well-being of teachers; and*

17 2. *The consistent implementation of discipline of pupils.*

18 **Sec. 5.** 1. Notwithstanding any other provision of this act, as
19 soon as is practicable after July 1, 2023:

20 (a) The Governor shall appoint to the Advisory Committee:

21 (1) Two of the members described in paragraph (a) of
22 subsection 2 of section 3 of this act to terms that expire on July 1,
23 2024;

24 (2) One of the members described in paragraph (a) of
25 subsection 2 of section 3 of this act to a term that expires on July 1,
26 2025; and

27 (3) Two of the members described in paragraph (a) of
28 subsection 2 of section 3 of this act to terms that expire on July 1,
29 2026.

30 (b) The Majority Leader of the Senate shall appoint to the
31 Advisory Committee the member described in paragraph (b) of
32 subsection 2 of section 3 of this act to a term that expires on July 1,
33 2025.

34 (c) The Speaker of the Assembly shall appoint to the Advisory
35 Committee the member described in paragraph (c) of subsection 2
36 of section 3 of this act to a term that expires on July 1, 2026.

37 2. As used in this section, "Advisory Committee" means the
38 Advisory Committee on the Safety and Well-Being of Teachers
39 created by section 3 of this act.

40 **Sec. 6.** This act becomes effective on July 1, 2023.
