AN ACT making appropriations to and authorizing the expenditure of money by the Division of Child and Family Services of the Department of Health and Human Services for the replacement of computer hardware and associated software, equipment and vehicles and for deferred maintenance projects; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** There is hereby appropriated from the State General Fund to the
- 2 Division of Child and Family Services of the Department of Health and Human
- 3 Services the sum of \$686,846 for the Information Services budget account for the
- 4 replacement of computer hardware and associated software.
- 5 **Sec. 2.** There is hereby appropriated from the State General Fund to the
- 6 Division of Child and Family Services of the Department of Health and Human
- 7 Services the sum of \$179,070 for the Information Services budget account for the
- 8 replacement of computer servers.
- 9 **Sec. 3.** There is hereby appropriated from the State General Fund to the
- 10 Division of Child and Family Services of the Department of Health and Human
- 11 Services the sum of \$343,646 for the Summit View Youth Center budget account
- 12 for deferred maintenance projects.
- 13 **Sec. 4.** There is hereby appropriated from the State General Fund to the
- 14 Division of Child and Family Services of the Department of Health and Human

1 Services the sum of \$55,030 for the Summit View Youth Center budget account for
2 the replacement of commercial cleaning and kitchen equipment.

3 **Sec. 5.** There is hereby appropriated from the State General Fund to the
4 Division of Child and Family Services of the Department of Health and Human
5 Services the sum of \$143,948 for the Caliente Youth Center budget account for the
6 replacement of equipment for security and operations.

7 **Sec. 6.** There is hereby appropriated from the State General Fund to the
8 Division of Child and Family Services of the Department of Health and Human
9 Services the sum of ~~(\$61,408)~~ **\$96,988** for the Caliente Youth Center budget
10 account for the replacement of vehicles.

11 **Sec. 7.** There is hereby appropriated from the State General Fund to the
12 Division of Child and Family Services of the Department of Health and Human
13 Services the sum of ~~(\$56,744)~~ **\$61,103** for the Caliente Youth Center budget
14 account for deferred maintenance projects.

15 **Sec. 8.** There is hereby appropriated from the State General Fund to the
16 Division of Child and Family Services of the Department of Health and Human
17 Services the sum of \$363,767 for the Nevada Youth Training Center budget
18 account for deferred maintenance projects.

19 **Sec. 9.** There is hereby appropriated from the State General Fund to the
20 Division of Child and Family Services of the Department of Health and Human
21 Services the sum of \$190,692 for the Nevada Youth Training Center budget
22 account for the replacement of vehicles.

23 **Sec. 10.** 1. There is hereby appropriated from the State General Fund to the
24 Division of Child and Family Services of the Department of Health and Human
25 Services the sum of \$90,894 for the Youth Parole Services budget account for the
26 replacement of radios.

27 2. Expenditure of \$90,893 not appropriated from the State General Fund or
28 the State Highway Fund is hereby authorized during Fiscal Year 2023-2024 and
29 Fiscal Year 2024-2025 by the Division of Child and Family Services of the
30 Department of Health and Human Services for the same purpose as set forth in
31 subsection 1.

32 **Sec. 11.** There is hereby appropriated from the State General Fund to the
33 Division of Child and Family Services of the Department of Health and Human
34 Services the sum of \$467,040 for the Southern Nevada Child and Adolescent
35 Services budget account for deferred maintenance projects.

36 **Sec. 12.** There is hereby appropriated from the State General Fund to the
37 Division of Child and Family Services of the Department of Health and Human
38 Services the sum of \$21,917 for the Southern Nevada Child and Adolescent
39 Services budget account for the replacement of water heaters.

40 **Sec. 13.** Any remaining balance of the appropriations made by sections 1 to
41 12, inclusive, of this act must not be committed for expenditure after June 30, 2025,
42 by the entity to which the appropriation is made or any entity to which money from
43 the appropriation is granted or otherwise transferred in any manner, and any portion
44 of the appropriated money remaining must not be spent for any purpose after
45 September 19, 2025, by either the entity to which the money was appropriated or
46 the entity to which the money was subsequently granted or transferred, and must be
47 reverted to the State General Fund on or before September 19, 2025.

48 **Sec. 14.** This act becomes effective upon passage and approval.
