SUMMARY—Revises provisions governing peace officers. (BDR 23-651)

AN ACT relating to peace officers; revising provisions relating to the required contents of an application for certification as a peace officer; requiring a law enforcement agency to provide to the Peace Officers’ Standards and Training Commission certain notice and information concerning peace officers employed by the agency; prohibiting a law enforcement agency from requiring a peace officer to make certain attestations concerning cannabis as a condition precedent to employment; prescribing requirements for certain standards adopted by regulation of the Commission; disqualifying certain persons from serving as peace officers; requiring the Executive Director of the Commission to report certain information to the National Decertification Index of the International Association of Directors of Law Enforcement Standards and Training or an equivalent database; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

- 1 Existing law sets forth provisions governing peace officers and creates the
- 2 Peace Officers’ Standards and Training Commission, which generally provides for
- 3 the training, education and certification of peace officers. (Chapter 289 of NRS)
- 4 Existing law requires an application for certification as a peace officer to include
- 5 the social security number of the applicant and a statement regarding the payment
- 6 of child support. (NRS 289.560, 289.570) **Section 2** of this bill additionally
- 7 requires an application for certification as a peace officer to include an affidavit
- 8 stating that the applicant: (1) is not disqualified from serving as a peace officer; (2)
- 9 has not been discharged, disciplined or asked to resign from employment with a



10 law enforcement agency for certain conduct; and (3) has not resigned from  
11 employment or otherwise separated from employment with a law enforcement  
12 agency while an investigation concerning certain alleged conduct was pending.  
13 **Section 2** also requires the Commission to: (1) deny an application for certification  
14 that does not include the required affidavit; and (2) search the National  
15 Decertification Index of the International Association of Directors of Law  
16 Enforcement Standards and Training, or an equivalent database, to ensure that the  
17 name of the applicant does not appear in any such index or database. **Section 6** of  
18 this bill makes a conforming change to indicate the proper placement of **sections 2**  
19 **and 3** of this bill in the Nevada Revised Statutes.

20 **Section 3** requires a law enforcement agency to immediately notify the  
21 Commission if a peace officer employed by the agency: (1) is charged with certain  
22 crimes; or (2) resigns from employment or otherwise separates from employment  
23 with the agency while an investigation concerning alleged misconduct is pending.  
24 **Section 3** also requires a law enforcement agency to provide certain information to  
25 the Commission concerning a peace officer who resigns or otherwise separates  
26 from employment with the agency while an investigation concerning alleged  
27 misconduct is pending.

28 With certain exceptions, existing law prohibits a law enforcement agency from  
29 requiring a peace officer to disclose certain information as a condition precedent to  
30 a promotion, job assignment or other personnel action. (NRS 289.030) **Section 5** of  
31 this bill additionally prohibits a law enforcement agency from requiring a peace  
32 officer to provide an oral or written attestation concerning any use of cannabis by  
33 the peace officer that occurred before the peace officer submitted his or her  
34 application for employment with the law enforcement agency as a condition  
35 precedent to employment as a peace officer.

36 Existing law requires the Commission to adopt regulations establishing  
37 minimum standards for the certification and decertification, recruitment, selection  
38 and training of peace officers. (NRS 289.510) **Section 7** of this bill provides that  
39 the standards prescribed by regulations adopted by the Commission: (1) must not  
40 prohibit the certification of an applicant solely on the basis that the applicant has  
41 engaged in the adult use of cannabis or the medical use of cannabis; (2) must not  
42 require the decertification of a peace officer solely on the basis that the peace  
43 officer has engaged in the adult use of cannabis or the medical use of cannabis; and  
44 (3) must require the decertification of a peace officer upon a determination by the  
45 Commission that the peace officer knowingly provided false or misleading  
46 information in his or her application for certification. **Section 7** also makes  
47 conforming changes to reorganize certain provisions relating to regulations adopted  
48 by the Commission. **Section 4** of this bill defines certain terms for the purposes of  
49 certain requirements relating to cannabis prescribed by **sections 5 and 7**.

50 Existing law provides that a person who has been convicted of a felony in this  
51 State or any other state is not qualified to serve as a peace officer. (NRS 289.555)  
52 **Section 9** of this bill makes this prohibition applicable regardless of whether the  
53 person has had the conviction expunged or sealed. **Section 9** also provides that a  
54 person is not qualified to serve as a peace officer if the person has been: (1)  
55 convicted of domestic violence in this State or any other state, regardless of  
56 whether such a conviction was sealed or expunged; (2) reported to the National  
57 Decertification Index or an equivalent database; or (3) decertified or has had his or  
58 her certificate or license to practice or serve as a peace officer revoked or annulled  
59 by the Commission or a certifying or licensing authority in any other state.

60 Existing law requires the Commission to appoint an Executive Director of the  
61 Commission and authorizes the Executive Director to perform certain acts relating  
62 to the certification of peace officers. (NRS 289.520, 289.530) **Section 8** of this bill  
63 requires the Executive Director to report to the National Decertification Index or an



64 equivalent database: (1) the name of each decertified peace officer; and (2) any  
65 other information required by the Index or database, as applicable.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     **Section 1.** Chapter 289 of NRS is hereby amended by adding  
2 thereto the provisions set forth as sections 2 and 3 of this act.

3     **Sec. 2. 1.** *An application for certification as a peace officer*  
4 *must include an affidavit stating that the applicant:*

5         *(a) Is not disqualified from serving as a peace officer pursuant*  
6 *to NRS 289.555;*

7         *(b) Has not been discharged, disciplined or asked to resign*  
8 *from employment with a law enforcement agency in this State or*  
9 *any other state for conduct which would, under the regulations*  
10 *adopted by the Commission pursuant to NRS 289.510, constitute*  
11 *grounds for denying certification or revoking the certificate of a*  
12 *peace officer; and*

13         *(c) Has not resigned from employment or otherwise separated*  
14 *from employment with a law enforcement agency in this State or*  
15 *any other state while an investigation concerning allegations of*  
16 *conduct which would, under the regulations adopted by the*  
17 *Commission pursuant to NRS 289.510, constitute grounds for*  
18 *denying certification or revoking the certificate of a peace officer,*  
19 *was pending.*

20     **2.** *The Commission shall summarily deny any application for*  
21 *certification as a peace officer if the application does not include*  
22 *the affidavit required by subsection 1.*

23     **3.** *The Commission shall, for each applicant for certification*  
24 *as a peace officer, search the National Decertification Index of the*  
25 *International Association of Directors of Law Enforcement*  
26 *Standards and Training, or an equivalent database maintained for*  
27 *the purpose of serving as a national registry of certificate or*  
28 *license revocation actions relating to peace officer misconduct, to*  
29 *ensure that the name of the applicant does not appear in any such*  
30 *index or database.*

31     **Sec. 3.** *A law enforcement agency shall:*

32         **1.** *Immediately notify the Commission if a peace officer*  
33 *employed by the agency:*

34             *(a) Is charged with a crime for which the regulations adopted*  
35 *by the Commission pursuant to NRS 289.510 authorize the*  
36 *Commission to revoke or suspend the certificate of the peace*  
37 *officer; or*



1 *(b) Resigns from employment or otherwise separates from*  
2 *employment with the agency while an investigation concerning*  
3 *alleged misconduct is pending; and*

4 *2. If a peace officer resigns or otherwise separates from*  
5 *employment while an investigation concerning alleged misconduct*  
6 *is pending, provide to the Commission a written summary of the*  
7 *outcome of the investigation as soon as practicable after*  
8 *completing the investigation.*

9 **Sec. 4.** NRS 289.010 is hereby amended to read as follows:

10 289.010 As used in this chapter, unless the context otherwise  
11 requires:

12 1. "Administrative file" means any file of a peace officer  
13 containing information, comments or documents about the peace  
14 officer. The term does not include any file relating to an  
15 investigation conducted pursuant to NRS 289.057 or a criminal  
16 investigation of a peace officer.

17 2. *"Adult use of cannabis" has the meaning ascribed to it in*  
18 *NRS 678A.075.*

19 3. "Law enforcement agency" means any agency, office,  
20 bureau, department, unit or division created by any statute,  
21 ordinance or rule which:

22 (a) Has a duty to enforce the law; and

23 (b) Employs any person upon whom some or all of the powers  
24 of a peace officer are conferred pursuant to NRS 289.150 to  
25 289.360, inclusive.

26 ~~3.~~ 4. *"Medical use of cannabis" has the meaning ascribed*  
27 *to it in NRS 678A.215.*

28 5. "Peace officer" means any person upon whom some or all of  
29 the powers of a peace officer are conferred pursuant to NRS  
30 289.150 to 289.360, inclusive.

31 ~~4.~~ 6. "Punitive action" means any action which may lead to  
32 dismissal, demotion, suspension, reduction in salary, written  
33 reprimand or transfer of a peace officer for purposes of punishment.

34 7. *"Screening test" means a test of a person's blood, urine,*  
35 *hair or saliva to detect the general presence of a controlled*  
36 *substance or other drug.*

37 **Sec. 5.** NRS 289.030 is hereby amended to read as follows:

38 289.030 **1.** A law enforcement agency shall not require any  
39 peace officer to ~~disclose~~:

40 (a) *Disclose* the peace officer's assets, debts, sources of income  
41 or other financial information or make such a disclosure a condition  
42 precedent to a promotion, job assignment or other personnel action  
43 unless that information is necessary to:

44 ~~1.)~~ (1) Determine the peace officer's credentials for transfer to  
45 a specialized unit;



1 ~~[2.]~~ (2) Prevent any conflict of interest which may result in any  
2 new assignment; or

3 ~~[3.]~~ (3) Determine whether the peace officer is engaged in  
4 unlawful activity.

5 (b) *Provide an oral or written attestation concerning any use  
6 of cannabis by the peace officer that occurred before the peace  
7 officer submitted his or her application for employment with the  
8 law enforcement agency as a condition precedent to employment  
9 with the agency as a peace officer.*

10 2. *Nothing in this section shall be construed to prohibit a law  
11 enforcement agency from:*

12 (a) *Requiring a peace officer to provide an oral or written  
13 attestation concerning any use of cannabis by the peace officer  
14 that has occurred after the submission of his or her application for  
15 employment with the law enforcement agency as a condition  
16 precedent to employment with the agency as a peace officer; or*

17 (b) *Adopting a policy that requires a peace officer to submit to  
18 a screening test as:*

19 (1) *A condition precedent to employment; or*

20 (2) *A condition for continued employment.*

21 3. *As used in this section, "use of cannabis" includes the  
22 adult use of cannabis and the medical use of cannabis.*

23 **Sec. 6.** NRS 289.450 is hereby amended to read as follows:

24 289.450 As used in NRS 289.450 to 289.680, inclusive, *and*  
25 *sections 2 and 3 of this act*, unless the context otherwise requires,  
26 the words and terms defined in NRS 289.460 to 289.490, inclusive,  
27 have the meanings ascribed to them in those sections.

28 **Sec. 7.** NRS 289.510 is hereby amended to read as follows:

29 289.510 1. The Commission:

30 (a) Shall meet at the call of the Chair, who must be elected by a  
31 majority vote of the members of the Commission.

32 (b) Shall provide for and encourage the training and education  
33 of persons whose primary duty is law enforcement to ensure the  
34 safety of the residents of and visitors to this State.

35 (c) ~~[Shall adopt regulations establishing minimum standards for  
36 the certification and decertification, recruitment, selection and  
37 training of peace officers. The regulations must establish:~~

~~(i)}~~ (g) Shall develop and approve a standard curriculum of certified training programs in crisis intervention, which may be made available in an electronic format, and which address specialized responses to persons with mental illness and train peace officers to identify the signs and symptoms of mental illness, to de-escalate situations involving persons who appear to be experiencing a behavioral health crisis and, if appropriate, to connect such persons to treatment. A peace officer who completes any program developed pursuant to this paragraph must be issued a certificate of completion.

39 *whether such a conviction was expunged or sealed;*

43 *(c) A misdemeanor crime of domestic violence, as defined in*

15 tasks that are necessary to carry out the provisions of this act; and

16      (b) On October 1, 2023, for all other purposes.
