SUMMARY—Revises provisions relating to public safety.

AN ACT relating to public safety; establishing provisions governing the operation of a personal delivery device; imposing certain requirements on a personal delivery device operator; providing a civil penalty; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law provides pedestrians on or near a highway with certain rights and
2 imposes certain duties. (NRS 484B.280-484B.297) Existing law authorizes the
3 operation of a mobile carrying device on sidewalks and in crosswalks and provides
4 that such a device has, in general, the rights and duties of a pedestrian.
5 (NRS 484B.790)

6 **Section 3** of this bill defines the term “personal delivery device” to mean an
7 electrically powered device that: (1) is intended primarily to transport cargo on
8 sidewalks, crosswalks and other pedestrian areas; (2) is not intended to carry
9 passengers; and (3) is equipped with technology that allows navigation with or
10 without the active control or monitoring of a natural person. **Section 1** of this bill
11 provides that a personal delivery device is not a “vehicle” for purposes of existing
12 law governing travel on public highways. (NRS 482.135) **Section 5** of this bill; (1)
13 authorizes a personal delivery device to operate on sidewalks, in crosswalks and on
14 highways if crossing at an intersection; (2) prohibits such a device from
15 transporting hazardous material, transporting a person or unreasonably interfering
16 with pedestrians or vehicle traffic; and (3) provides that such a device has, in
17 general, the rights and duties of a pedestrian. **Section 5** also requires a personal
18 delivery device to include a unique identifying number and a means of identifying
19 and contacting the personal delivery device operator. **Section 4** of this bill defines
20 the term “personal delivery device operator” to mean a person or entity that
21 exercises control or monitoring over the operation and navigation of a personal
22 delivery device, not including a person who solely: (1) requests or receives a
23 delivery; (2) arranges for or dispatches a delivery; or (3) stores, charges or



24 maintains a personal delivery device. **Section 6** of this bill requires a personal
25 delivery device operator to maintain a policy of general liability insurance to cover
26 any damages caused by the operation of personal delivery devices under the control
27 of the operator. **Section 8** of this bill provides that a violation of the provisions of
28 **section 5 or 6** is a civil infraction. **Section 7** of this bill makes a conforming change
29 to indicate the proper placement of **sections 3 and 4** in the Nevada Revised
30 Statutes.

31 Existing law authorizes the governing body of a county or city, respectively, to
32 enact ordinances which regulate the time, place and manner of operation of mobile
33 carrying devices. (NRS 244.3565, 268.41015) **Sections 9 and 10** of this bill create
34 similar authority for personal delivery devices.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 482.135 is hereby amended to read as follows:

2 482.135 Except as otherwise provided in NRS 482.36348,
3 “vehicle” means every device in, upon or by which any person or
4 property is or may be transported or drawn upon a public highway.

5 The term does not include:

6 1. Devices moved by human power or used exclusively upon
7 stationary rails or tracks;

8 2. Mobile homes or commercial coaches as defined in chapter
9 489 of NRS;

10 3. Electric bicycles;

11 4. Electric personal assistive mobility devices;

12 5. Electric scooters; ~~or~~

13 6. A mobile carrying device as that term is defined in NRS
14 484B.029 ~~or~~; or

15 7. *A personal delivery device as that term is defined in section*
16 *3 of this act.*

17 **Sec. 2.** Chapter 484B of NRS is hereby amended by adding
18 thereto the provisions set forth as sections 3 to 6, inclusive, of this
19 act.

20 **Sec. 3. 1.** *“Personal delivery device” means an electrically*
21 *powered device that:*

22 *(a) Is designed to operate autonomously, semi-autonomously*
23 *or remotely by a personal delivery device operator;*

24 *(b) Is equipped with technology that allows navigation with or*
25 *without the active control or monitoring of a natural person;*

26 *(c) Is intended primarily to transport cargo on sidewalks,*
27 *crosswalks and other pedestrian areas;*

28 *(d) Weighs less than 150 pounds when empty; and*

29 *(e) Has a maximum speed of 10 miles per hour.*

30 2. *The term does not include a mobile carrying device.*



1 **Sec. 4.** *“Personal delivery device operator” means a person*
2 *or entity that exercises control or monitoring over the operation*
3 *and navigation of a personal delivery device. The term does not*
4 *include a person or entity who solely:*

5 1. *Requests or receives the delivery or services of a personal*
6 *delivery device;*

7 2. *Arranges for or dispatches the requested services of a*
8 *personal delivery device; or*

9 3. *Stores, charges or maintains a personal delivery device.*

10 **Sec. 5.** 1. *Except as otherwise provided in section 9 or 10 of*
11 *this act, a personal delivery device may be operated on a sidewalk*
12 *or crosswalk if:*

13 (a) *The operator of the personal delivery device is capable of*
14 *actively monitoring and remotely controlling the navigation and*
15 *movement of the personal delivery device;*

16 (b) *The personal delivery device is equipped with a braking*
17 *device that enables the personal delivery device to come to a*
18 *controlled stop;*

19 (c) *The personal delivery device includes a unique identifying*
20 *number and a means of identifying and contacting the personal*
21 *delivery device operator; and*

22 (d) *The personal delivery device is operated in accordance with*
23 *any requirements imposed by this section.*

24 2. *A personal delivery device operator may not allow a*
25 *personal delivery device to:*

26 (a) *Operate on the highways of this State except when crossing*
27 *at an intersection or within a crosswalk;*

28 (b) *Fail to comply with any traffic-control signal or devices*
29 *that a pedestrian is obligated to comply with;*

30 (c) *Unreasonably interfere with pedestrians or vehicle traffic;*

31 (d) *Transport hazardous material as that term is defined in*
32 *NRS 459.7024; or*

33 (e) *Transport a person.*

34 3. *A personal delivery device has all the rights and duties of a*
35 *pedestrian except those which by their nature can have no*
36 *application or as otherwise provided in this section.*

37 4. *A violation of this section:*

38 (a) *Is not a misdemeanor;*

39 (b) *Shall not be deemed a moving traffic violation; and*

40 (c) *Is punishable by the imposition of a civil penalty of \$250.*

41 **Sec. 6.** *A personal delivery device operator shall maintain an*
42 *insurance policy that provides general liability coverage of not less*
43 *than \$100,000 for any damages arising from the combined*
44 *operations of any personal delivery devices under the control of*
45 *the personal delivery device operator.*



1 **Sec. 7.** NRS 484B.003 is hereby amended to read as follows:
2 484B.003 As used in this chapter, unless the context otherwise
3 requires, the words and terms defined in NRS 484B.007 to
4 484B.077, inclusive, *and sections 3 and 4 of this act* have the
5 meanings ascribed to them in those sections.

6 **Sec. 8.** NRS 484B.760 is hereby amended to read as follows:
7 484B.760 1. It is a civil infraction punishable pursuant to
8 NRS 484A.703 to 484A.705, inclusive, for any person to do any act
9 forbidden or fail to perform any act required in NRS 484B.768 to
10 484B.790, inclusive ~~{}~~ *and sections 5 and 6 of this act.*

11 2. The parent of any child and the guardian of any ward shall
12 not authorize or knowingly permit the child or ward to violate any
13 of the provisions of chapters 484A to 484E, inclusive, of NRS.

14 3. The provisions applicable to bicycles, electric bicycles and
15 electric scooters apply whenever a bicycle, an electric bicycle or an
16 electric scooter is operated upon any highway or upon any path set
17 aside for the exclusive use of bicycles, electric bicycles and electric
18 scooters subject to those exceptions stated herein.

19 **Sec. 9.** NRS 244.3565 is hereby amended to read as follows:
20 244.3565 1. Except as otherwise provided in ~~{subsection 2,}~~
21 *this section*, the board of commissioners of each county in this State
22 may, to protect the health and safety of the public, enact an
23 ordinance which ~~{regulates}~~ :

24 (a) *Regulates* the time, place and manner of the operation of a
25 mobile carrying device *or personal delivery device* in the
26 unincorporated areas of the county, including, without limitation, by
27 prohibiting the use of a mobile carrying device *or personal delivery*
28 *device* in a specified area of the county ~~{}~~; *and*

29 (b) *Establishes additional standards for the safe operation of a*
30 *personal delivery device.*

31 2. A board of county commissioners, in enacting an ordinance
32 pursuant to subsection 1, may not prohibit the use of a mobile
33 carrying device *or personal delivery device* on a sidewalk in the
34 county that is more than 36 inches wide.

35 3. *The board of county commissioners of each county in this*
36 *State may not enact an ordinance which regulates:*

37 (a) *The design, manufacture, maintenance, taxation or*
38 *assessment of a personal delivery device; or*

39 (b) *The types of property, other than alcohol, that may be*
40 *transported by a personal delivery device.*

41 4. *Nothing in this section shall be construed to prohibit a*
42 *board of county commissioners from requiring a personal delivery*
43 *device operator to obtain from the county a business license or pay*
44 *any business license fee in the same manner that is generally*



1 *applicable to any other business that operates within the*
2 *jurisdiction of the board of county commissioners.*

3 5. As used in this section ~~[, "mobile"]~~ :

4 (a) "Mobile carrying device" has the meaning ascribed to it in
5 NRS 484B.029.

6 (b) "Personal delivery device" has the meaning ascribed to it
7 in section 3 of this act.

8 (c) "Personal delivery device operator" has the meaning
9 ascribed to it in section 4 of this act.

10 **Sec. 10.** NRS 268.41015 is hereby amended to read as
11 follows:

12 268.41015 1. Except as otherwise provided in ~~[subsection 2,]~~
13 *this section*, the city council or other governing body of each
14 incorporated city in this State, whether or not organized under
15 general law or special charter, may, to protect the health and safety
16 of the public, enact an ordinance which ~~[regulates]~~ :

17 (a) *Regulates* the time, place and manner of the operation of a
18 mobile carrying device *or personal delivery device* in the city,
19 including, without limitation, by prohibiting the use of a mobile
20 carrying device *or personal delivery device* in a specified area of the
21 city ~~[]~~ ; and

22 (b) *Establishes additional standards for the safe operation of a*
23 *personal delivery device.*

24 2. A city council or governing body, in enacting an ordinance
25 pursuant to subsection 1, may not prohibit the use of a mobile
26 carrying device *or personal delivery device* on a sidewalk in the city
27 that is more than 36 inches wide.

28 3. *The city council or other governing body of each*
29 *incorporated city in this State, whether organized under general*
30 *law or special charter, may not enact an ordinance which*

1 ***(b) "Personal delivery device" has the meaning ascribed to it***
2 ***in section 3 of this act.***

3 ***(c) "Personal delivery device operator" has the meaning***
4 ***ascribed to it in section 4 of this act.***

5 **Sec. 11.** 1. This section becomes effective upon passage and
6 approval.

7 2. Sections 1 to 10, inclusive, of this act become effective:

8 (a) Upon passage and approval for the purpose of adopting any
9 regulations and performing any other preparatory administrative
10 tasks that are necessary to carry out the provisions of this act; and

11 (b) On January 1, 2024, for all other purposes.
