AN ACT making appropriations to the Department of Education for the replacement of computer hardware and associated software; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** There is hereby appropriated from the State General
- 2 Fund to the Department of Education the sum of \$7,212 for the
- 3 Educator Effectiveness budget account for the replacement of
- 4 computer hardware and associated software.
- 5 **Sec. 2.** There is hereby appropriated from the State General
- 6 Fund to the Department of Education the sum of \$14,424 for the
- 7 Office of the Superintendent budget account for the replacement of
- 8 computer hardware and associated software.
- 9 **Sec. 3.** There is hereby appropriated from the State General
- 10 Fund to the Department of Education the sum of \$2,404 for the
- 11 Office of Early Learning and Development budget account for the
- 12 replacement of computer hardware and associated software.
- 13 **Sec. 4.** There is hereby appropriated from the State General
- 14 Fund to the Department of Education the sum of \$2,404 for the



1 Literacy Programs budget account for the replacement of computer
2 hardware and associated software.

3 **Sec. 5.** There is hereby appropriated from the State General
4 Fund to the Department of Education the sum of \$2,404 for the
5 Standards and Instructional Support budget account for the
6 replacement of computer hardware and associated software.

7 **Sec. 6.** There is hereby appropriated from the State General
8 Fund to the Department of Education the sum of \$4,808 for the
9 Assessments and Accountability budget account for the replacement
10 of computer hardware and associated software.

11 **Sec. 7.** There is hereby appropriated from the State General
12 Fund to the Department of Education the sum of \$2,404 for the
13 Student and School Support budget account for the replacement of
14 computer hardware and associated software.

15 **Sec. 8.** There is hereby appropriated from the State General
16 Fund to the Department of Education the sum of \$19,441 for the
17 Data Systems Management budget account for the replacement of
18 computer hardware and associated software.

19 **Sec. 9.** There is hereby appropriated from the State General
20 Fund to the Department of Education the sum of \$7,212 for the
21 District Support Services budget account for the replacement of
22 computer hardware and associated software.

23 **Sec. 10.** There is hereby appropriated from the State General
24 Fund to the Department of Education the sum of \$2,404 for the
25 Individuals with Disabilities Education Act budget account for the
26 replacement of computer hardware and associated software.

27 **Sec. 11.** There is hereby appropriated from the State General
28 Fund to the Department of Education the sum of \$4,808 for the Safe
29 and Respectful Learning budget account for the replacement of
30 computer hardware and associated software.

31 **Sec. 12.** Any remaining balance of the appropriations made by
32 sections 1 to 11, inclusive, of this act must not be committed for
33 expenditure after June 30, 2025, by the entity to which the
34 appropriation is made or any entity to which money from the
35 appropriation is granted or otherwise transferred in any manner, and
36 any portion of the appropriated money remaining must not be spent
37 for any purpose after September 19, 2025, by either the entity to
38 which the money was appropriated or the entity to which the money
39 was subsequently granted or transferred, and must be reverted to the
40 State General Fund on or before September 19, 2025.

41 **Sec. 13.** This act becomes effective upon passage and
42 approval.
