AB 457 (BDR 43-1078) relates to license plates and would remove the requirement for DMV to automatically reissue license plates every 8 years; customers wanting to get duplicate or substitute plates must apply for them according to established provisions governing the issuance of duplicate or substitute plates. This bill becomes effective on October 1, 2023.

This change is being done at the request of DMV; the fiscal impacts shown here have also been identified and included in the proposed License Plate Factory (Budget Account 4712) budget for fiscal years 2024 and 2025. These impacts can be found in decision unit E244 of budget account 4712.
