Comment: Section 6 of the bill would allow an injured employee to request an independent medical examination (IME) for permanent partial disability (PPD) to determine if the employee has a ratable impairment. Additionally, if the employee is seeking to dispute an initial rating, they would also be allowed to request an IME to obtain a second rating. Currently, approximately half of the County's accepted claims receive a PPD rating. The changes in this bill could require Clark County to pay for IME's for PPD ratings for all accepted claims. The County accepts an estimated 720 claims per year, and the average cost for either an IME or a PPD is \$1,475. Currently, an employee is entitled to one IME per calendar year. The proposed bill language could result in the County paying two additional IME's for each accepted claim each year, for an estimated annual cost of \$2.1 million. It is expected PPD payments will also increase as a result of this bill, but that amount cannot be determined. Note, fiscal impacts for FY24 are reduced, due to a January 1, 2024 effective date.
