PW states that there is no design standard for this type of traffic control device, but the current cost of a typical traffic signal is \$675K per intersection. Estimated # of at grade railroad crossings under County jurisdiction is 27 (including 16 in Moapa/Overton/Logandale area). The cost to bring electricity to locations that do not currently have power is not included, nor is the annual cost associated with the peace officer (@ LVMPD that's partially funded by the County) that must review the evidence before citations can be issued.
