Section 12 of the bill would require the Clark County Detention Center to provide methods of preventing the acquisition of HIV to inmates. Without knowing the quantity that would be distributed in a fiscal year, the fiscal impact is not determinable.

Comment: With respect to the provisions of this bill which require health plans for local governments to provide testing for, treatment of and prevention of certain communicable diseases, there are only two items which are not currently covered by Washoe County's employee health plan. The first provision is covering the cost of condoms to covered members aged 13+. The County does not anticipate a material fiscal impact as a result of this provision. The second provision is covering the cost of all FDA approved human immunodeficiency virus (HIV) and hepatitis C medications without restriction, except for step therapy. Currently, HIV and Hepatitis C medications costs range between \$50 to over \$20,000 per fill. The number of plan members who may need such fills and the quantity and cost of such fills is unknown. As such, a reliable estimate of the financial effect of this bill on Washoe County cannot be determined.
