DETR has reviewed AB428_R1 and believes there will be costs related to both development/implementation of a software solution as well as two full time staff positions. The provisions of section 2.3 require the Governor's Office of Workforce Innovation (GOWINN) to develop and implement a Career Pathways Demonstration program. To comply with these provisions, DETR believes that GOWINN will require a Management Analyst 3 to oversee the Career Pathways Demonstration program as a program manager as well as a Management Analyst 1 to serve as a program coordinator. It is estimated that these positions will incur approximately \$1,500 of in-state travel costs per year in support of the Career Pathways Demonstration program. Based on the agency's prior experience, DETR/GOWINN believe that the cost for the implementation of the needed software solution will be approximately \$250,000. These costs are detailed in Supporting Document 1.
