The Aging and Disability Services Division (ADSD) reviewed Assembly Bill 422 (1st Reprint) and determined that it will have a fiscal impact on the division and is submitting an unsolicited fiscal note.

The bill as written would require a pilot program through Autism Treatment Assistance. This program would provide evidence-based services and supports for children diagnosed with fetal alcohol spectrum disorders. Pilot program based on available funding to end no later than December 31, 2025. The division will need two additional state staff - Developmental Specialist IV and Administrative Assistant IV. Estimated costs of \$146,397 in SFY 23-24, \$187,714 in SFY 24-25 and \$93,857 in the future biennia. The analysis assumes that the two state positions would end when the pilot program terminates. The positions would need to be retained if the program continues beyond the end date specified in the bill.

Program training costs are estimated at \$84,000 in SFY 23-24, \$40,000 in SFY 24-25 and \$20,000 in the future biennia.

Six contractual staff will be needed to perform pilot program duties. Estimated total costs for these contractual staff and associated costs is \$2,403,598 in SFY 23-24, \$2,381,321 in SFY 24-25 and \$1,190,661 in the future biennia.
