Comment: BDR 1-900 is an act relating to background checks; revising provisions authorizing a person to petition certain boards or public officers to review his or her criminal history and determine whether the person is able to obtain a particular license, permit, certificate, registration or qualification; and other provisions related to civil fingerprint-based background checks...

AB503 BDR 1-900 sections 1-91 amend statutes to modify fingerprint specific language for the purposes of governmental entities conducting fingerprint-based background checks for employment, licensing, volunteering, registration, permits, certification, etc.

If AB503 BDR 1-900 is enacted as introduced, it may impact the Department of Public Safety's Records, Communications and Compliance Division (RCCD) with an unknown increase in workload to the Fingerprint Support Unit and the Fingerprint Examiner Unit. RCCD may request to return to the Interim Finance Committee in the 2023-2025 biennium should workload increases necessitate additional staffing. The Federal Bureau of Investigation (FBI) will need to review and approve the language of the bill to determine whether or not it meets the criteria pursuant to Public Law 92-544 as a condition of releasing its criminal history records. RCCD will coordinate the review by the FBI. If the language does not meet the criteria, RCCD will advise and coordinate with the sponsor and/or respective agency to amend the bill to include the appropriate language.

Comment: AB 503 (BDR 1-900) is a bill relating to governmental administration and proposes to revise certain criteria regarding background checks and fingerprinting required for certain professional licensees and occupations. The bill's language authorizes persons to petition professional or occupational licensing boards, including certain motor vehicle industry licensees, to review their criminal history and determine if they are able to obtain a license, permit, certificate, registration or qualification. The bill would also prohibit certain licensing boards from including a person's criminal history in reports submitted to certain governmental entities. The bill also revises requirements regarding background checks and fingerprinting for certain educational staff and requires applicants for various types of licenses to submit a set of fingerprints for criminal history review. Bill language also revises licensing requirements for certain dental practitioners and medical staff. The bill becomes effective upon passage and approval; Sec. 68 expires 2 years after the repeal of 42 U.S.C Sec. 666.

The Department has reviewed this bill and determined there will be no fiscal impact as currently written. DMV will not be required submit reports to other governmental agencies regarding criminal history results of its licensing applicants. The Department will create a petition form for persons to use if needed to review criminal history; these forms will be printed on demand for any person to request as a part of ongoing operations.
