Comment: The proposed bill authorizes the creation of an academic medical district and allows a participating entity to create a tax increment area consisting of all or part of the academic medical district. Any property taxes collected within the tax increment area would be allocated to a special account for the payment of bonds or other securities issued for the development of the academic medical district. Property tax revenue for all taxing agencies within a newly created tax increment area could be negatively impacted, as a portion of tax revenue would be redirected to the special account for the payment of bonds and other securities. In order to determine the fiscal impact, Clark County would need to know the boundaries of any new tax increment area, the fiscal year that adoption of an ordinance would take effect, and the property values within the tax increment area at the time the ordinance would take effect. Additionally, the bill contemplates the creation of multiple districts, but it is unknown how many districts there will be. While this bill could have a negative fiscal impact on Clark County, since these factors cannot be known at this time, the amount cannot be determined.
