BDR 38-811 would allow recipients of the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) the ability to utilize benefits for the purchase of menstrual products. The estimated annual cost for the purchase of the products would be \$1,969,440 based on current eligibility of 8,206 individuals and is subject to constant fluctuation.

This type of benefit would not be supported currently for integration by the current statewide Management Information System (MIS) and would take a federal waiver to do so. Per the software developer, the cost at this time, if a waiver was received for such an implementation, is unidentifiable as it would affect the eligibility system, WIC approved vendors and EBT processing system. This program spent nearly \$30,000 to implement SB 109 passed during the 2021 Legislative Session to incorporate a data collection field for Sexual Orientation and Gender Identify (SOGI). This did not affect the system to the degree that BDR 38-811 would.

If the bill is passed, it would require a voucher system and monitoring. Printing costs to provide vouchers to purchase menstrual hygiene products for approximately 8,206 (as noted subject to change) eligible NV WIC participants per month for the year is approximately 98,472 vouchers (8,206 x 12).

In closing, this would have a fiscal impact to implement with true costs fluctuating due to participation levels and does not appear that it would be covered by the Code of Federal Regulations or waiver exceptions at this time.
