Comment: As written, this bill would result in University Medical Center of Southern Nevada's (UMC) commercial payor rates being capped at Medicare rates, which will impact UMC's reimbursements in two specific areas. First, UMC's commercial reimbursement would be decreased to Medicare levels. Second, UMC participates in a Managed Care Directed Payment program with Nevada Medicaid, which provides an enhanced rate of reimbursement for MCO services calculated based on the Average Commercial Rate (ACR) of UMC's five highest commercial payors. This bill would reduce the ACR to Medicare rates, lowering the scope of the Managed Care Directed Payments. Medicare rates do not fully cover the cost of delivery of service, with the American Hospital Association estimating that Medicare reimbursement only covers on average 84 cents of every dollar spent on providing care to Medicare recipients. Additionally, Medicare rates are lower than the rates UMC has currently negotiated through available supplemental payment mechanisms. A revenue loss of the magnitude estimated as a result of this bill could impact UMC's ability to deliver critical community services only provided by UMC.

Comment: The provisions of this BDR that require an independent commission to establish fixed rates for health care goods and services (i.e. hospitals, emergency medical care, surgical centers) in alignment with Medicare rates would likely result in a reduction in expenditures for Washoe County. Based upon historical costs, Medicare rates are typically better than those available through private contracting, unless the facility appeals the fixed rates. Generally, this could lower the cost of health benefits for Washoe County as long as the fixed rates were in line with Medicare rates; however, if the fixed rates are not in line with Medicare there is potential for costing more than privately contracting health care goods and services. Because the fixed rates have not been determined, the fiscal impact to Washoe County cannot be determined.
