BDR 40-324 relates to homelessness and would revise several processes that allow such persons to: obtain copies of birth certificates; receive assistance when applying for state identification (ID) cards; revising DMV procedures for issuance of ID cards to such persons, and; requires certain counties to develop homeless strategy plans. Sections 1-6 of the BDR become effective on October 1, 2023 and sections 7-8 become effective on July 1, 2023.

The Department has reviewed this bill and determined there will be an impact as written. Currently persons under 25 who declare themselves homeless can get a one-time waiver from all fees to get an ID card; the bill's provisions would remove the one-time aspect of the waiver and make it available free every time for these persons. This would affect a limited subset of DMV customers applying for ID cards; in FY22 approximately 414 youth under 25 received a homeless waiver from ID card fees.

DMV is currently engaged in its "transformation effort" (DTE), to revise business processes, reorganize, and move systems to a cloud solution. This will greatly improve DMV services and allow customer transactions online. DTE project delivery will continue into 2026 and involves over 100 staff and contractors. The proposed effective date will require programing, testing and implementation in the legacy system, estimated at 911 hours. This creates risk and additional work. Due to DTE, DMV is unable to absorb work for changes. Work completed will be done by new contract programmers.

Basis for Calculation:

(1) For FY22, 414 youth under 25 applied for a homeless waiver from fees for ID cards. Using this as a base figure and projecting that passage of the bill would make it easier for this population to apply for cards and removes the limit of a one time waiver, DMV anticipates there will be increased participation. DMV estimates FY23 participation will be flat from FY22, a 50% increase in homeless youths applying for ID's in FY24, and 25% increase from that figure in FY25.

- (2) Split projected increases into age categories of under age of 18 and ages 18-24 based on percentages displayed in HUD data.
- (2) Multiply increases in each year by ID card fees for each age category to calculate projected card fee loss to the Department. ID Cards for under 18 years of age = \$3. ID cards for over 18 years of age = \$9.
- (3) Card production cost loss estimated at a flat \$3.25 per card.
- (4) 911 estimated programming hours performed by contract programmers, at a rate of \$109.62 per hour equals \$99,863.82 cost to program the CARRS application for changes.
