Conversely, Washoe County could realize additional revenues through receipt of donations, gifts and grants disbursed by the Department of Health and Human Services pursuant to this bill. Because the amount of, allowable uses for, and Washoe County's eligibility to receive such donations, gifts and grants is unknown a reliable estimate of such revenues cannot be determined.
