#### **Explanation**

As currently drafted, BDR 54-158 creates new licensing and regulatory requirements for debt buyers under current law NRS 649; current law applies to third-party debt collectors and not debt buyers. BDR 54-158, if passed, would add approximately 200 new licensees under the Financial Institutions Division's (FID) supervision. FID will be responsible for regulatory development, implementation, examinations, complaint investigations, and all other regulatory matters pertaining thereto.

With the anticipated increase of 200 licensees created from BDR 54-158, FID will require three (3) new positions to adequately establish, examine, and manage the increase in the new type of collection product being added to NRS 649. The three (3) positions will consistent of: one (1) Financial Institutions Examiner II, Grade 35 and two (2) Financial Institutions Examiner I, Grade 33. In addition, this BDR will generate additional revenue.
