Comment: \$100,000 is a very rough and conservative guess, as we currently have an electronic surveillance system on our public transit in Carson City, but we do not maintain the video for 90 days, we keep it for a very short period of time, in the event of an accident or incident (the system dates back to 2008, and still works as needed). Carson City's bus system does not have a remote access option, we have to remove the hard drive from the bus to view in the event of an incident. This bill would require additional storage space, and software to maintain and organize data files, some type of remote access, as well as at least 1 FTE as a contract operator to operate and maintain the video system, as well as establish rules and penalties for anyone who damages or manipulates the video.
