Comment: Section 3, subsection 4 of this bill requires that each member of a public body attend at least 25 percent of the meetings of the public body each year in person at a physical location designated for the meeting where members of the general public are permitted to attend and participate. Our agency hosts at least 6 meetings in a typical year; to comply with this provision, we would need to meet in person at least twice. As our board members and staff are split between Reno and Las Vegas, at least 3 people would need to travel between the two cities for one or more days. Airfare and a potential overnight stay for three people is estimated at \$600/person for two-way airfare and one night of accommodations (\$1800 total per meeting). Board members are also entitled to a per diem travel allowance, which can be estimated at \$100/day (\$600 total per meeting). The cost of renting a meeting room and conferencing equipment fluctuates between \$150 and \$500, depending on the location (estimated at \$200 total per meeting).

Comment: Since 2020 and the COVID pandemic, travel to attend Board meetings in person has ceased. Prior to that time, in-state travel was greatly curtailed by the availability of video teleconferencing, allowing the working professionals who serve on the Optometry Board to use their volunteer time more efficiently by being relieved from traveling away from their homes and businesses to attend Optometry Board meetings in other areas of the state, many of which required an overnight stay to accommodate both airline and meeting schedules. As a result, the Board has minimized its travel budget in recent biennia.

This measure requires each Board member to attend not fewer than 25% of the 6 to 8 annual meetings in-person, which would require half of the Board to travel to one meeting and the other half to travel to one meeting. In-person meetings also would require staff travel. An average meeting with 4 travelers will cost approximately \$4,000 for airfare, hotel, per diem, ground transportation, mileage, airport parking, etc. Additionally, if no public facilities are available (such as during the legislative session) the Board may incur a cost for the facility hosting the meeting of approximately \$500 per meeting to host the event and provide video-teleconferencing equipment.

Comment: The Board will incur additional travel/per diem, meeting space/supply, and salary expenses as a result of requiring attendance by each member of the Board at "at least 25% of meetings each year in person at a physical location designated for the meeting where members of the general public are permitted to attend and participate." Our Board is comprised of 7 members, with 4 in Reno and 3 in Las Vegas currently. Two Reno members will be terming out in July 2023. Expenses are broken down below for both scenarios and assuming 3 members remain in Las Vegas.

Currently meetings are held via Zoom teleconference and physically hosted and open to the public from the Board office in Reno. This new requirement would require additional expenses for the following:

- Travel costs for Las Vegas members to travel to Reno at least once per year
 - Airfare LAS-RNO (same day depart/return) estimated @ \$250 x 3 Members = \$750
 - Per Diem (same day depart/return) estimated @ \$51.75 x 3 Members = \$155.25
- TOTAL \$905.25

OR

- Travel/meeting space costs for Board staff to travel to Las Vegas and host a meeting there once per year and and potentially pay for meeting space at least once per year.
 - Airfare RNO-LAS (same day depart/return) estimated @ \$250.00 / 2 staff = \$500.00
 - Per Diem (same day depart/return) estimated @ \$51.75 x 2 staff = \$103.50
 - Day Meeting Space/Supplies = estimated based on prior expenses @ \$300.00

Comment: The agency has reviewed this bill and has determined that there is a fiscal impact to the State Board of Osteopathic Medicine (Board). Section 3 of the bill requires each member of the Board to attend at least 25 percent of the meetings of the public body in person each year at a physical location designated for the meeting where members of the general public are permitted to attend and participate. The Board conducts 11 meetings per year in Las Vegas. Up to three Board members may be located in or near Reno/Carson City thereby necessitating payment for flights, hotel, and per diem for meals. Good faith cost estimates of a roundtrip flight to/from RNO to LAS is \$400 per person; a room for two nights is \$350 per person; and the per diem rate for the day before and after the meeting is \$45 per person and \$64 per person the day of the meeting (\$154 per person for three days). Transportation to and from hotel to Board office is approximately \$40 round trip per day. The total cost estimate is \$944 per board member per meeting.
