Chair Cohen:

Senate Bill 364 (2nd Reprint): Makes various changes relating to cultural remains. (BDR 33-533)

Becky Peratt, Committee Policy Analyst:

<u>Senate Bill 364 (2nd Reprint)</u> makes various changes relating to cultural remains [<u>Exhibit C</u>]. Senator Krasner submitted an amendment which is attached for the Committee's review. To summarize the changes:

- Clarifies in subsection 1 of section 3 that regulations proposed to carry out provisions
 of existing law relating to the protection of Indian burial sites and historic and
 prehistoric sites must incorporate the values, beliefs, and traditions of the Indian
 tribes; and requires the Nevada Indian Commission to consult on such with
 Indian tribes and submit the results to the Office of Historic Preservation, State
 Department of Conservation and Natural Resources;
- It revises subsection 1(a) of section 1;
- Removes the requirement in subsection 2 of section 1; and
- Removes the requirement for the Department to deliver proposed regulations related to section 1 of the bill.

Chair Cohen:

I want to thank the proponents of the bill for working with both our Legal Staff and the various affected agencies to get the language homed in and aligned with the intent.
