Chair Monroe-Moreno:

[Roll was called. Committee rules and protocol were explained.] I know we had a long joint session meeting, but we are here today for a work session on <u>Assembly Bill 268</u>. It is a bill that we heard last week, and it makes an appropriation to the Office of Finance, Office of the Governor for the payment of retention incentives to employees of the Executive Department of the State of Nevada.

Assembly Bill 268: Makes an appropriation to the Office of Finance in the Office of the Governor for the payment of retention incentives to employees of the Executive Department of the State Government. (BDR S-1037)

Sarah Coffman, Assembly Fiscal Analyst:

Assembly Bill 268 was heard in the Committee on Ways and Means on March 8, 2023, and makes appropriations to the Office of Finance in the Office of the Governor for the purpose of issuing two \$500 payments to each employee of the Executive Department of the State Government. The \$500 payment would be made to employees who are employed on March 31, 2023, and those who are employed on June 16, 2023.

Within <u>The Executive Budget</u>, the Governor recommended \$20 million for this purpose in a onetime appropriation. However, it is Fiscal Analysis Division staff's understanding that this amount was increased by \$3 million to a total of \$23 million to account for professional staff within the Nevada System of Higher Education.

The testimony that was provided on March 8, 2023, came from the Governor's Chief of Staff, Ben Kieckhefer, and the Governor's Budget Director, Amy Stephenson. Those who were in support of the bill were Cisco Aguilar, Secretary of State; Susan Martinez, Executive Secretary-Treasurer, Nevada State AFL-CIO; Randy Soltero, representing AFSCME International; Douglas Unger, Nevada Faculty Alliance; and Kent Ervin, Nevada Faculty Alliance.

During the hearing, the Chair requested that a budget amendment be prepared for this piece of legislation. You should have the mock-up for Proposed Amendment 3527 [Exhibit C]. In this amendment, section 1 changes the amount from \$23 million to \$20,970,000 for the

Executive Department of the State, which excludes professional staff of the Nevada System of Higher Education; persons whose compensation is paid from a budget account that is not subject to Nevada Revised Statutes (NRS) 353.150 to NRS 353.246, which is also known as the State Budget Act; and persons who are in temporary, intermittent, or seasonal positions. This funding would be provided to the Judicial Department of the State Government. In Section 2, \$325,000 is provided to the Legislative Fund for the Legislative Department staff, and in section 3, \$81,000 is provided to the Public Employees' Retirement System.

Chair Monroe-Moreno:

I hope the members had an opportunity between our two meetings today to review the amendment. I will accept a motion to amend and do pass.

ASSEMBLYWOMAN JAUREGUI MOVED TO AMEND AND DO PASS ASSEMBLY BILL 268.

ASSEMBLYWOMAN BACKUS SECONDED THE MOTION.
