AN ACT making an appropriation to Goodwill of Southern Nevada for expanding workforce development initiatives; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to Goodwill of Southern Nevada the sum of
3 \$3,000,000 for expanding workforce development initiatives.
4 2. Upon acceptance of the money appropriated by subsection 1,
5 Goodwill of Southern Nevada agrees to:
6 (a) Prepare and transmit a report to the Interim Finance
7 Committee on or before December 18, 2026, that describes each
8 expenditure made from the money appropriated by subsection 1
9 from the date on which the money was received by Goodwill of
10 Southern Nevada through December 1, 2026;
11 (b) Prepare and transmit a final report to the Interim Finance
12 Committee on or before September 17, 2027, that describes each
13 expenditure made from the money appropriated by subsection 1
14 from the date on which the money was received by Goodwill of
15 Southern Nevada through June 30, 2027; and
16 (c) Upon request of the Legislative Commission, make available
17 to the Legislative Auditor any of the books, accounts, claims,
18 reports, vouchers or other records of information, confidential or



1 otherwise, of Goodwill of Southern Nevada, regardless of their form
2 or location, that the Legislative Auditor deems necessary to conduct
3 an audit of the use of the money appropriated by subsection 1.

4 3. Any remaining balance of the appropriation made by
5 subsection 1 must not be committed for expenditure after June 30,
6 2027, by the entity to which the appropriation is made or any entity
7 to which money from the appropriation is granted or otherwise
8 transferred in any manner, and any portion of the appropriated
9 money remaining must not be spent for any purpose after
10 September 17, 2027, by either the entity to which the money was
11 appropriated or the entity to which the money was subsequently
12 granted or transferred, and must be reverted to the State General
13 Fund on or before September 17, 2027.

14 **Sec. 2.** This act becomes effective upon passage and approval.
