SUMMARY—Revises provisions governing elections. (BDR 24-821)

AN ACT relating to elections; requiring, under certain circumstances, the Secretary of State, county clerks and city clerks to ensure that voting materials and certain other elections information are posted on certain Internet websites and made available in certain languages; requiring the Secretary of State to establish a toll-free telephone number which may be used for a person to receive language interpretation or translation assistance relating to an election; requiring such telephone number to be posted at each polling place and on certain Internet websites and included on sample ballots; requiring the Secretary of State to include certain information related to a registered voter’s preferred language on an application to register to vote; requiring county and city clerks to make a good faith effort to appoint election board officers who are bilingual; revising the information relating to registered voters that is required to be included on the statewide voter registration list; requiring, under certain circumstances, a mechanical voting system to list offices, candidates and ballot measures in a voter’s preferred language; creating and setting forth the membership and duties of the Language Access Advisory Committee; making an appropriation to the Office of the Secretary of State for certain expenses relating to language access and the establishment of a toll-free telephone number; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law requires each voting system used by a county or city to provide  
2 voting materials in English and every language in which voting materials are  
3 required to be prepared pursuant to federal law. (52 U.S.C. § 10503; NRS  
4 293.2699) **Section 5** of this bill requires the Secretary of State to ensure that voting  
5 materials and other elections information are posted or made available at a polling  
6 place in certain languages. **Section 5** further requires the Secretary of State, on or  
7 before January 1 of each odd-numbered year, to review certain data on persons who  
8 are members of a minority group and are of limited-English proficiency in the  
9 State. Based on the review of such data, under certain circumstances, the Secretary  
10 of State and certain county and city clerks are required to ensure that voting  
11 materials and other information are provided in certain other languages. **Sections**  
12 **11-16, 18, 19 and 26-28.5** of this bill make conforming changes to require that  
13 certain elections materials be available in such languages.

14 **Section 37.5** of this bill requires the Secretary of State to review certain data in  
15 sufficient time for voting materials to be prepared for the 2024 General Election.

16 **Sections 2-4** of this bill, respectively, define the terms "limited-English  
17 proficiency," "minority group" and "voting materials." **Section 9** of this bill makes  
18 a conforming change to indicate the proper placement of **sections 2-4** in the Nevada  
19 Revised Statutes.

20 **Section 6** of this bill requires the Secretary of State and authorizes a county  
21 clerk to establish a toll-free telephone number which may be used by any person to  
22 receive language interpretation or translation assistance relating to an election.  
23 **Sections 7, 14-16, 18, 22, 27 and 28** of this bill require each polling place, sample  
24 ballot and Internet website of the county or city clerk, as applicable, to include such  
25 telephone number.

26 **Section 8** of this bill requires the Secretary of State to include on all forms for  
27 an application to preregister or register to vote certain language authorizing a  
28 person who registers to vote to request a sample ballot in a language other than  
29 English.

30 Existing law requires each county and city clerk to appoint registered voters to  
31 act as election board officers for the various polling places in the county or city, as  
32 applicable. (NRS 293.217, 293C.220) **Sections 10 and 25** of this bill require the  
33 county or city clerk to make a good faith effort to appoint election board officers  
34 who are bilingual.

35 Existing law requires the Secretary of State to prescribe forms for applications  
36 to preregister or register to vote. (NRS 293.507) **Section 17** of this bill requires the  
37 Secretary of State to include on each such application a line on which to enter the  
38 applicant's state or country of birth and a language preference. **Section 20** of this  
39 bill requires such information to be included on the statewide voter registration list.

40 Existing law requires the Secretary of State to establish a system on the Internet  
41 website of the Office of the Secretary of State to allow persons by computer to  
42 preregister and register to vote, cancel such preregistration or registration, update  
43 such preregistration or registration and determine at what polling place or places he  
44 or she is entitled to vote. The system is required to be user friendly. (NRS 293.671)  
45 **Section 19** of this bill requires the system to also be accessible in each language in  
46 which the Secretary of State is required to provide information and voting materials  
47 pursuant to **section 5**.

48 **Section 21** of this bill provides that if the mechanical voting system used in a  
49 county or city is capable of providing a registered voter's ballot in the preferred  
50 language of the voter other than English, the county or city clerk, as applicable,  
51 shall ensure that the list of offices and candidates and the statement of ballot  
52 measures for which the voter is entitled to vote is in that preferred language.

53 **Section 34** of this bill creates the Language Access Advisory Committee within  
54 the Office of the Secretary of State, consisting of the Secretary of State or his or her



55 designee, and certain other members. **Section 35** of this bill requires the Advisory  
56 Committee to: (1) identify certain programs and services that address language  
57 accessibility of elections and voting materials; (2) coordinate with community  
58 organizations to determine language accessibility of elections and voting materials;  
59 (3) act as a liaison between the Office of the Secretary of State and community  
60 organizations; (4) make certain annual assessments relating to language  
61 accessibility; and (5) make certain recommendations to the Office of the Secretary  
62 of State relating to language accessibility. **Section 36** of this bill sets forth certain  
63 requirements for meetings of the Advisory Committee. **Section 37** of this bill: (1)  
64 requires the Secretary of State to appoint the initial members of the Advisory  
65 Committee before January 1, 2024; and (2) staggers the terms of the initial  
66 members.

67 **Section 36.7** of this bill makes an appropriation to the Office of the Secretary  
68 of State to carry out certain provisions of this bill relating to language access and  
69 the establishment of the toll-free telephone number required pursuant to **section 6**.

70 **Sections 23 and 24** of this bill make conforming changes to indicate the proper  
71 placement of **section 22** in the Nevada Revised Statutes.

72 **Section 29** of this bill makes a conforming change to indicate the proper  
73 placement of **section 7** in the Nevada Revised Statutes.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 293 of NRS is hereby amended by adding  
2 thereto the provisions set forth as sections 2 to 8, inclusive, of this  
3 act.

4 **Sec. 2.** *“Limited-English proficiency” means being unable to*  
5 *speak or understand English adequately to participate in the*  
6 *electoral process.*

7 **Sec. 3.** *“Minority group” includes, without limitation, United*  
8 *States citizens of Chinese heritage.*

9 **Sec. 4.** *“Voting materials” means the following written*  
10 *materials:*

11 1. *Applications to preregister or register to vote;*

12 2. *Ballots and the instructions for the use of such ballots,*  
13 *including, without limitation, mail ballots, sample ballots and*  
14 *provisional ballots;*

15 3. *Voting instructions;*

16 4. *Information and instructions relating to the location of*  
17 *polling places, including, without limitation, vote centers,*  
18 *permanent polling places for early voting and temporary branch*  
19 *polling places and the hours during which such polling places will*  
20 *be open;*

21 5. *Any notices required to be provided for an election*  
22 *pursuant to title 24 of NRS;*

23 6. *Ballot questions;*

24 7. *Any forms prepared for an election to assist voters; and*



1 8. Any other voting materials the Secretary of State requires  
2 to be translated by a regulation adopted pursuant to section 5 of  
3 this act.

4 Sec. 5. 1. The Secretary of State shall ensure that voting  
5 materials and other elections information that is posted on the  
6 Internet website of the Office of the Secretary of State or the  
7 system of approved electronic transmission established pursuant to  
8 NRS 293D.200 is available on such website and system of  
9 approved electronic transmission in any language in which voting  
10 materials are required to be prepared pursuant to 52 U.S.C. §  
11 10503. If any such language does not have a standard writing  
12 system, the information required to be posted must be set forth in  
13 an audio recording in the language. Except as otherwise provided  
14 in this subsection, the Secretary of State shall use a translator who  
15 is certified in the specific language to translate the information  
16 required pursuant to this subsection. If such a certified translator  
17 is not available to translate the information required pursuant to  
18 this subsection, the Secretary of State shall make a continuous  
19 effort to find such a certified translator or coordinate with the  
20 minority group for translation assistance.

21 2. Each county clerk and city clerk shall ensure that the  
22 Internet website of the county or city clerk, as applicable, has  
23 posted in a prominent location a link to the information on the  
24 website of the Office of the Secretary of State required pursuant to  
25 subsection 1.

26 3. The Secretary of State shall, on or before January 1 of  
27 each odd-numbered year, review data on persons who are  
28 members of a minority group and are of limited-English  
29 proficiency in the State, based on the American Community  
30 Survey conducted by the Bureau of the Census of the United  
31 States Department of Commerce or language preference  
32 information collected by the Secretary of State. In addition to the  
33 requirements set forth in subsections 1 and 2, if, based on such  
34 data:

35 (a) The Secretary of State finds that there are at least 5,000  
36 qualified electors in this State who are members of a minority  
37 group and are of limited-English proficiency, the Secretary of  
38 State shall ensure that voting materials and other elections  
39 information that are posted on the Internet website of the Office of  
40 the Secretary of State or set forth in the system of approved  
41 electronic transmission established pursuant to NRS 293D.200 are  
42 available in the language or languages of the minority group. If  
43 any such language does not have a standard writing system, the  
44 information required to be posted or made available must be set  
45 forth in an audio recording in the language. Except as otherwise



1 *provided in this paragraph, the Secretary of State shall use a*  
2 *translator who is certified in the specific language to translate the*  
3 *information required pursuant to this paragraph. If such a*  
4 *certified translator is not available to translate the information*  
5 *required pursuant to this paragraph, the Secretary of State shall*  
6 *make a continuous effort to find such a certified translator or*  
7 *coordinate with the minority group for translation assistance.*

8 *(b) Except as otherwise provided in this paragraph, the*  
9 *Secretary of State finds that there are at least 20,000 qualified*  
10 *electors in this State who are members of a minority group and are*  
11 *of limited-English proficiency, the Secretary of State shall*  
12 *collaborate with each county clerk to ensure that voting materials*  
13 *and other elections information that are required to be posted or*  
14 *made available at a polling place or on the Internet website of the*  
15 *county clerk are posted or available in the language or languages*  
16 *of the minority group. If any such language does not have a*  
17 *standard writing system, the information required to be posted or*  
18 *made available must be set forth in an audio recording in the*  
19 *language. Except as otherwise provided in this paragraph, the*  
20 *Secretary of State shall use a translator who is certified in*  
21 *the specific language to translate the information required*  
22 *pursuant to this paragraph. If such a certified translator is not*  
23 *available to translate the information required pursuant to this*  
24 *paragraph, the Secretary of State shall make a continuous effort*  
25 *to find such a certified translator or coordinate with the minority*  
26 *group for translation assistance. The cost of preparing and*  
27 *providing voting materials and other elections information in any*  
28 *language required pursuant to this paragraph is a charge against*  
29 *the State and must be paid from the Reserve for Statutory*  
30 *Contingency Account upon recommendation by the Secretary of*  
31 *State and approval by the State Board of Examiners. The*  
32 *provisions of this paragraph do not apply to the extent that a*  
33 *county clerk is required pursuant to paragraph (c) to ensure that*  
34 *voting materials and other elections information that are required*  
35 *to be posted or made available at a polling place or on the Internet*  
36 *website of the county clerk are posted or available in the language*  
37 *or languages of the minority group.*

38 *(c) The Secretary of State finds that there are at least 5,000*  
39 *qualified electors in a county who are members of a minority*  
40 *group and are of limited-English proficiency, the Secretary of*  
41 *State shall notify the county clerk and the county clerk shall*  
42 *ensure that voting materials and other elections information that*  
43 *are required to be posted or made available at a polling place or*  
44 *on the Internet website of the county clerk are posted or available*  
45 *in the language or languages of the minority group. If any such*



1 *language does not have a standard writing system, the information*

17 *website of the city clerk are posted or available in the language or*  
18 *languages of the minority group. If any such language does not*  
19 *have a standard writing system, the information required to be*  
20 *posted or made available must be set forth in an audio recording*  
21 *in the language. Except as otherwise provided in this paragraph,*  
22 *the city clerk shall use a translator who is certified in the specific*  
23 *language to translate the information required pursuant to this*  
24 *paragraph. If such a certified translator is not available to*  
25 *translate the information required pursuant to this paragraph, the*  
26 *city clerk shall make a continuous effort to find such a certified*  
27 *translator or coordinate with the minority group for translation*  
28 *assistance.*

29 *4. The Secretary of State may adopt regulations requiring any*  
30 *additional voting material that must be translated pursuant to this*  
31 *section.*

32 **Sec. 6. 1. The Secretary of State shall:**

33 *(a) Establish a toll-free telephone number which may be used*  
34 *by any person in this State to receive language interpretation or*  
35 *translation assistance relating to an election, including, without*  
36 *limitation, voter registration or other voter assistance; and*

37 *(b) Post the toll-free telephone number established pursuant to*  
38 *paragraph (a) on the Internet website of the Office of the*  
39 *Secretary of State.*

40 **2. A county clerk:**

41 *(a) May establish a toll-free telephone number which may be*  
42 *used by any person in the county to receive language*  
43 *interpretation or translation assistance relating to an election,*  
44 *including, without limitation, voter registration or other voter*  
45 *assistance; and*



1 (b) If such a toll-free telephone number is established  
2 pursuant to paragraph (a), post the toll-free telephone number on  
3 the Internet website of the county clerk.

4 3. Each county and city clerk shall post the toll-free  
5 telephone number established by the Secretary of State pursuant  
6 to subsection 1 on the Internet website of the county or city clerk,  
7 as applicable.

8 **Sec. 7.** The county clerk shall ensure that at each polling  
9 place for early voting the toll-free telephone number established  
10 by the Secretary of State and, if applicable, the toll-free number  
11 established by the county clerk pursuant to section 6 of this act for  
12 a voter to receive voter registration and other voter assistance  
13 during the period for early voting is posted in a conspicuous place.

14 **Sec. 8. 1.** The Secretary of State shall include on all forms  
15 for an application to preregister or register to vote prescribed by  
16 the Secretary of State, including, without limitation, a paper  
17 application and the form set forth on the system established by the  
18 Secretary of State pursuant to NRS 293.671 to allow persons to  
19 register to vote by computer, the following language in at least 14-  
20 point bold type:

33 2. Except as otherwise provided in this subsection, the county  
34 clerk and city clerk of the county and city where the voter is  
35 registered to vote must provide the voter who has indicated a  
36 preferred language other than English with a sample ballot in the  
37 preferred language. If, pursuant to section 5 of this act, a county  
38 or city clerk is not required to provide voting materials in the  
39 preferred language of the voter, the county or city clerk, as  
40 applicable, must provide the voter with a sample ballot in English  
41 until the clerk is required, pursuant to section 5 of this act, to  
42 provide voting materials in such language.

43 **Sec. 9.** NRS 293.010 is hereby amended to read as follows:  
44 293.010 As used in this title, unless the context otherwise  
45 requires, the words and terms defined in NRS 293.016 to 293.121,





1 inclusive, *and sections 2, 3 and 4 of this act*, have the meanings  
2 ascribed to them in those sections.

3 **Sec. 10.** NRS 293.217 is hereby amended to read as follows:

4 293.217 1. The county clerk of each county shall appoint and  
5 notify registered voters to act as election board officers for the  
6 various polling places in the county as provided in NRS 293.220 to  
7 293.227, inclusive, and NRS 293.269929. *The county clerk shall*  
8 *make a good faith effort to appoint election board officers who are*  
9 *bilingual in a language that voting materials are required to be*

37 voter in the county and each person who registers to vote or updates  
38 his or her voter registration information not later than the 14 days  
39 before the election a mail ballot for every election. The county clerk  
40 shall make reasonable accommodations for the use of the mail ballot  
41 by a person who is elderly or disabled, including, without limitation,  
42 by providing, upon request, the mail ballot in 12-point type to a  
43 person who is elderly or disabled. *If a county clerk is required to*

8 (a) Each active registered voter who:

9 (1) Resides within the State, not later than 20 days before the
