SUMMARY—Makes a contingent appropriation for allocation to Mondays Dark, Inc. for building a certain facility. (BDR S-708)

AN ACT making a contingent appropriation for allocation to Mondays Dark, Inc. for the building of a facility in the Las Vegas, Nevada, area to provide space for the provision of educational, mental health and other services to the community; and providing other matters properly relating thereto.

## THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** 1. There is hereby appropriated from the State General Fund to the Interim Finance Committee the sum of \$5,000,000 for allocation to Mondays Dark, Inc. for the building of a facility in the Las Vegas, Nevada, area to provide space for the provision of educational, mental health and other services to the community.

Allocation of the money appropriated by subsection 1 is 7 2. contingent upon matching money being obtained by Mondays Dark, 8 Inc., including, without limitation, gifts, grants and donations to 9 Mondays Dark, Inc. from private and public sources of money other 10 than the appropriation made by subsection 1, for the building of 11 such a facility. The Interim Finance Committee shall not direct the 12 transfer of any portion of the money appropriated by subsection 1 13 until Mondays Dark, Inc. submits to the Committee proof 14





satisfactory that matching money in an equivalent amount has been
 committed.

3 3. Upon acceptance of the money appropriated by subsection 1,4 Mondays Dark, Inc. agrees to:

5 (a) Prepare and transmit a report to the Interim Finance 6 Committee on or before December 18, 2026, that describes each 7 expenditure made from the money appropriated by subsection 1 8 from the date on which the money was received by Mondays Dark, 9 Inc. through December 1, 2026;

(b) Prepare and transmit a final report to the Interim Finance
Committee on or before September 17, 2027, that describes each
expenditure made from the money appropriated by subsection 1
from the date on which the money was received by Mondays Dark,
Inc. through June 30, 2027; and

15 (c) Upon request of the Legislative Commission, make available 16 to the Legislative Auditor any of the books, accounts, claims, 17 reports, vouchers or other records of information, confidential or 18 otherwise, of Mondays Dark, Inc., regardless of their form or 19 location, that the Legislative Auditor deems necessary to conduct an 20 audit of the use of the money appropriated by subsection 1.

21 Any remaining balance of the appropriation made by 4. 22 subsection 1 must not be committed for expenditure after June 30. 23 2027, by the entity to which the appropriation is made or any entity 24 to which money from the appropriation is granted or otherwise 25 transferred in any manner, and any portion of the appropriated 26 money remaining must not be spent for any purpose after 27 September 17, 2027, by either the entity to which the money was 28 appropriated or the entity to which the money was subsequently 29 granted or transferred, and must be reverted to the State General 30 Fund on or before September 17, 2027.

31 Sec. 2. This act becomes effective upon passage and approval.
