Electeds

(1) Fiscal Year 2025-2026 as 3 percent higher than the highest salary of an employee under the supervision of the elected officer that was in effect on January 1, 2025; and (2) each fiscal year thereafter as 3 percent higher than the highest salary of an employee under the supervision of the elected officer that has been approved by the board of county commissioners.

Section 1 further: (1) establishes the amount of the annual salaries for county commissioners for Fiscal Year 2025-2026; and (2) provides that for the 5 fiscal years following Fiscal Year 2025-2026, each county commissioner is entitled to an increase in the amount of his or her annual salary of 3 percent per fiscal year.
