The Nevada System of Higher Education (NSHE) has reviewed BDR24-11 and determined that there will be a fiscal impact due to lost revenue from providing space in public buildings at no charge. Each institution has estimated potential revenue losses based on historical event data, estimated number of events, standard room rental fees, and associated costs such as setup, custodial services, and audiovisual support. Additional costs, such as additional required security and overtime for weekend events, may apply but are unable to be determined.

### BDR24-11 Detailed Responses by Institution

# University of Nevada, Las Vegas

The Division of Student Affairs at UNLV has determined that there will be a fiscal impact for Section 1.1.a, Section 1.1.b.1, and Section 1.1.b.2. The fiscal impact would be loss of revenue to the UNLV Student Union estimated at \$2,400 per event. Four events are estimated in a presidential election year for an annual revenue loss of \$9,600, and two events are estimated in any year that is not a presidential election year for an annual revenue loss of \$4,800. Food and beverage costs, and security costs are billed separately.

### University of Nevada, Reno

The University of Nevada, Reno has reviewed AB 92 and has determined that the fiscal impact will be lost revenue. To determine that amount of fiscal year loss we used the amount for 6 events in fiscal year 2024-25 - this is \$1,281. This does not include administrative employee costs associated with the events as we currently absorb these costs. We are projecting the same fiscal impact in 2026-27, \$1,281, and beyond.

Nevada State University has reviewed the bill draft and determined there will be a fiscal impact from loss of revenue in the amount of \$5,400 per year. Historical data indicates an average of 4 events per year with the total revenue of \$5,400 (\$5,200 for space and \$200 in facilities support).

#### College of Southern Nevada

CSN has reviewed BDR 24-101 and has determined there will be a fiscal impact for Section 1. 1. (a) and 1. 1. (b) (1). There is no fiscal impact to Section 1. 1. (b) (2). The fiscal impact will be a loss of revenue. As such, CSN will use an estimated fiscal impact of \$467 per event for space usage, with an estimate of 3 events per non-election year. This would have a total fiscal impact of \$1,401 per non-election year. This calculation does not include overtime for weekend events, as that variable is possible but not typical. Any support from the University Police would be billed separately by the University Police

### Great Basin College

Great Basin College has reviewed AB 92 and determined there will be a fiscal impact due to the loss of room rental revenue. This assummes loss of rental revenue of \$322 five days per year. \$322 x 5 =\$1,610 This calculation is based on the usage of a large classroom or the area at GBC's Clocktower. The additional fees could include personnel at an hourly charge: Facilitator \$15 per hour, Custodial/Grounds \$25 per hour, Security \$40 per hour, Sound & Light Technician \$42 per hour, IT Technician \$50 per hour. Total estimate for 1 hour of use: \$322

## Truckee Meadows Community College

Truckee Meadows Community College has reviewed AB 92 and determined there will be a fiscal impact due to the loss of room rental revenue. This assumes loss of rental revenue of \$375 five days per year. \$375\*5 = \$1,875

### Western Nevada College

Western Nevada College has reviewed BDR 24-101 and has determined there will be a fiscal impact for Section 1. 1. (a) and 1. 1. (b) (1). There is no fiscal impact to Section 1. 1. (b) (2). The fiscal impact will be a loss of revenue. As such WNC will use an estimated a fiscal impact of \$492 per event with an estimate of 4 events per fiscal year (one meeting per quarter). This would be a total fiscal impact of \$1,968 per fiscal year. Any support by University Police would be billed separately by University Police.
