While the Nevada System of Higher Education cannot determine the fiscal impact of the proposed legislation on the Millennium Scholarship Trust Fund, we expect an increase in utilization of the scholarship, which would result in greater annual expenses to the program.

Section 4 directs the Board of Regents to establish an appeals process for students who failed a second time to meet continuing eligibility requirements. If the appeals process is centralized at the System level, a full-time position will be needed to manage the process, coordinate with the State Treasurer's Office, and respond to student inquiries.

The proposed legislation would also require the Board of Regents to establish a procedure for a student who is eligible for a Governor Guinn Millennium Scholarship (GGMS) and was enrolled in fewer than 15 semester credits during any semester during his or her first 2 years of enrollment at an institution within the System to receive more than the cost of 15 semester credits for a semester during his or her subsequent 2 years of enrollment. At least one institution (the University of Nevada, Las Vegas) determined that implementation would require additional administrative support.

While NSHE cannot determine the fiscal impact of the proposed legislation on the Millennium Scholarship Trust Fund, we expect an increase in utilization of the scholarship, which would result in greater annual expenses to the program.

Section 4 - directs the Board of Regents to establish an appeals process for students who have failed a second time to meet continuing eligibility requirements. Using Fall 2024 as an example and looking at students who failed a second time to meet continuing eligibility requirements at the end of that term, we would expect to see a substantial number of appeals submitted on a semesterly basis. At the end of Fall 2024, 835 NSHE students failed a second time to meet continuing eligibility requirements (342 @ UNLV; 254 @ UNR; 143 @ CSN; 45 @ TMCC; 43 @ NSU; 5 @ WNC; and 3 @ GBC). If the appeals process is centralized at the System level, a full-time position will be needed to manage the process, coordinate with the State Treasurer's Office, and respond to student inquiries. Although the appeals provisions in the bill are effective 7/1/27, the figures provided include a position for the entire fiscal year to allow for implementation activities (Grade C/Q1 on the NSHE salary schedule).

University of Nevada, Las Vegas

The proposed legislation would require the Board of Regents to establish a procedure for a student who is eligible for a Millennium Scholarship and was enrolled in fewer than 15 semester credits during any semester during his or her first 2 years of enrollment at an institution within the System to receive more than the cost of 15 semester credits for a semester during his or her subsequent 2 years of enrollment. The bill also includes other criteria changes and reporting requirements.

UNLV's Academic Affairs Office has reviewed SB176 BDR 34-45 and determined that implementation would require additional administrative support, specifically a Financial Aid Scholarship Counselor and a Computer Science Graduate Assistant.
