City/County: Clark County Approved by: Jennifer Green, Director of Budget & Financial Planning Comment: The proposed changes provided for in BDR 38-450 SB29 are specific to the State of Nevada Department of Health and Human Services ("Department") to develop a system of reimbursements to "accountable care organization(s)", which are to provide high-quality primary care. Clark County does not operate accountable care organizations or primary care clinics; however, University Medical Center (UMC), may be become qualified as an "accountable care organization", allowing for additional Medicaid reimbursements, wherein which UMC did not previously qualify. SB29 also proposes each biennium, the Department survey healthcare providers who participate in Medicaid to solicit recommendations to improve the manner in which providers of health care request and receive reimbursement from Medicaid; and the utilization of providers of health care who participate in Medicaid. This survey may allow UMC the ability to provide direct feedback to DHHS, with a result of more timely Medicaid reimbursements, aiding in cost recovery.

Comment: The fiscal impact of this bill on Washoe County cannot be determined at this time due to uncertainties regarding applicability. It does not appear that Washoe County would participate in the newly created "accountable care organization", but we are unable to definitively make this determination without more information on this type of provider. However, if passed, this bill may provide additional ability for groups of providers to provide services eligible for Medicaid reimbursement, which could potentially increase the pool of available care in the County-included resources to support such care. If this potential "expansion" would impact the county via increased Medicaid/unmet free care responsibilities is unknown.
