The cost of special elections varies depending on the specific office and district involved. Based on historical data, if a County-wide special election were to occur, the cost to conduct such an election would be approximately \$1,072,714.05.

Comment: Section 1, Subsection 1 of this bill requires an elected public officer to resign from their current office before filing nomination papers for any other elective public office unless specific exemptions apply. The cost associated with staff time to address a resulting vacancy cannot be precisely determined; however, at least two special meetings would be required as a minimum. Depending on whether the vacancy is filled through an appointment or a special election, additional special meetings, meet-and-greet sessions, and community engagement efforts may be necessary, potentially increasing costs. These costs would be incurred per vacancy, but not every situation would require additional special meetings. For reference, the City of Henderson incurred approximately \$250,000 in costs to conduct a special election in 2023, providing a potential cost estimate for similar scenarios.

Comment: Per City Of Las Vegas Charter, the organization has to address an elected vacancy within a period not exceeding 30 days. In the context of the 2024 elections, it meant that the incumbent officials and the two candidates running for Mayor would have tendered their resignation in March, prior to the commencement of the candidate filing period. This circumstance would necessitate the organization and completion of a special election prior to the scheduled June election. To illustrate the financial implications of such an occurrence, the City referenced to the quoted cost for a "single-ward" special election from the CCED in 2024, which amounted to \$720,000. If we consider the 2024 Primary as a case study, the City would have faced the challenge of filling four vacated seats (those held by Knudsen, Diaz, Seaman, and Crear) in advance of the June 2024 elections. The projected cost for a special election encompassing all four wards would exceed \$3 million. Moreover, during the 30-day vacancy period, the absence of a full council would impede our ability to establish a quorum necessary for conducting City Council meetings.
