### School District: White Pine County School District

Comment: The proposed legislation requiring the implementation of human trafficking prevention curriculum in grades 6-12 would likely have a notable fiscal impact on the the District. The district may incur costs in adapting and implementing the new curriculum standards developed by the Department of Education into their existing health courses. Additionally, the requirement for at least one employee at each school to receive specialized training on human trafficking prevention will result in training (professional development) expenses. If the school district were to host training and hire a consultant to provide training and education, it would cost approximately \$2,500 for professional fees and travel related expenses. All designated school professionals would attend the same training instead of traveling out of the area and incurring greater expense. The district will also need to develop or purchase educational materials on this topic for students and parents, which represents another cost. This is difficult to quantify without greater specificity but we anticipate a cost of \$75 per student for approximately 700 students (6 - 12) for instructional materials (i.e. textbooks, workbooks, digital resources, software licensing, consumable classroom supplies, etc.) in the first year of implementation and approximately 1/2 of the cost per year moving forward. There may be staffing adjustments necessary to meet the criteria for instructors of this new content, potentially leading to hiring or additional training costs for existing staff but this would be accomplished with existing staff. Administrative costs associated with implementing the new curriculum, coordinating training, and ensuring compliance should also be considered. We've included an estimate of approximately \$25 per student or \$17,500 in the first year and 1/2 the cost in subsequent years.
