Comment: Having child care facilities in residences where the child care giver is a tenant poses a multitude of issues. Having a child care facility in apartments may hinder the quality of life of other residents. It may also pose safety issues as apartments don't generally have homes built to be just ground level, which could lead to safety and fall risks. The needs and requirements for a child care facility out of a residence would not be able to adhere to the requirements of the city's home occupation permit. Having to re-zone districts to conform to the proposed requirements would not be feasible as the zoning districts are limited and the city does not have the sufficient resources in order to be accommodating.

Comment: Section 3(1) of this bill requires cities and counties to adopt ordinances allowing child care facilities to operate in all residential zoning districts. The cost estimates assume that a new ordinance, implemented through a zoning code text amendment, will be necessary in fiscal year 2025-26 to comply with all legislative provisions outlines in section 3(1) and section 3(2)(a-b). Developing this ordinance is projected to require approximately half of the annual workload of a full-time senior planner, including public noticing requirements for the text amendment. Given these demands, it is anticipated that the work will need to be contracted out at a rate of \$60 per hour for 1,040 hours, which represents the midpoint of the senior planner salary range at the City. Additionally, substantial community engagement will be necessary. To support the policy drafting and adoption process, a cost of \$5,000 is estimated for services and supplies. This process is expected to be resource-intensive, encompassing agenda administration, public notices, drafting resolutions and ordinances, developing staff reports for at least three public meetings, and preparing for and attending those meetings. From a business licensing perspective, section 1(1) of the bill prevents homeowners' associations from prohibiting licensed childcare providers and section 2(1) allows renters to operate home-based childcare businesses. As a result of this increased regulatory flexibility, the City anticipates a rise in business license applications for childcare businesses, leading to increased revenue from business licensing and application fees and some ongoing revenue from business license renewals. Due to several unknown factors, including the number of new applicants, a revenue estimate cannot be determined.

Comment: AB185 primarily addresses the operation and zoning regulations of child care facilities (CCFs). The bill proposes amendments to existing zoning rules, allowing CCFs to be established in residential areas. It also prohibits the regulation of the type of facility, its capacity, and the duration of stays, which could have adverse effects on the surrounding communities.

Additionally, AB185 permits the establishment of permanent facilities that offer overnight accommodations, effectively allowing boarding house-type facilities in residential zones where such uses are currently restricted by the County. As currently drafted, this legislation would eliminate the County's existing public hearing process, mandating the approval of a CCF irrespective of its size, location, or length of stay. Consequently, the County would lose its ability to regulate and mitigate the impact of CCFs, potentially affecting the quality of life in the neighborhoods where these facilities are implemented.
