The requirement to post detailed purchasing information and procedures could necessitate additional administrative time and resources, and the new council's recommendations might influence future procurement policies. Overall, the fiscal impact is likely to be relatively small but would require the district to allocate some resources to ensure compliance with the new legislative requirements.

Comment: SB71 proposes the establishment of the Nevada Diverse Business Advisory Council and the dissolution of the Regional Business Development Advisory Council for Clark County. While the bill outlines new posting requirements for public entities regarding the information displayed on their websites—such as details about the types of supplies and materials purchased and the procedures for requesting contracts—these requirements largely align with the existing practices of Clark County's Purchasing Department.

The Purchasing Department is already engaged in reporting similar data, ensuring compliance with transparency and procurement standards. Consequently, the transition to the Nevada Diverse Business Advisory Council and the associated posting requirements would not necessitate significant new resources or changes to existing processes. This continuity in reporting practices means that the fiscal impact on Clark County would be minimal, if any.

In summary, since the Purchasing Department is already fulfilling most of the reporting requirements set forth in SB71, the implementation of this bill would not create a substantial financial burden on the County, thereby mitigating any potential fiscal impact.
