Comment: Currently, Washoe County is not tracking data on the number of individuals who are released on bail and subsequently arrested for felony charges, leading to their return to detention. Based on discussions with the Washoe County Sheriff's Office - Detention Bureau, it is estimated that approximately 10 individuals would fall into this category annually. For each individual, the average detention period is projected to be 6 months (180 days). The average daily housing cost is \$160, though this could increase depending on specialized treatment requirements. The estimated fiscal impact for housing these individuals in the detention facility would be approximately \$288,000 per year (\$160 x 180 days x 10 individuals).
