Comment: BDR 24-101 requires that rooms or spaces in public buildings be provided to certain political parties without charge for certain purposes. The Public Employees' Benefits Program (PEBP) meeting space is not typically open to the general public except during scheduled PEBP Board meetings and events with limited access to PEBP's facilities. PEBP will allow use of the meeting space with consideration to these restrictions.

The Public Employees' Benefits Program (PEBP) has determined there will be no fiscal impact if meeting space is requested during normal business hours. Should use of PEBP's meeting space be required after normal business hours PEBP may incur an increase in personnel expenses, specifically overtime costs for staff to unlock facilities and be on premises for the duration of the meeting.

Comment: This legislation would require that rooms or spaces in buildings that are open to the general public be made available without charge to central committees of major political parties in presidential election years for any purpose and during other years for the purpose of conducting precinct meetings. However, this legislation does not specifically identify which state-owned buildings are open to the general public.

Per NRS 331.135 (1), all of the Legislature's properties are reserved for use by the Legislature, both during and between legislative sessions. Based on this statute, the Legislative Counsel Bureau (LCB) has concluded that the Legislature's properties are not open to the general public for purposes of this legislation and therefore this legislation would have no fiscal impact on the LCB.

If future legislative action were to change the LCB's policy on the Legislature's properties and specifically identify the Legislature's properties as being open to the general public, there would be a fiscal impact on the LCB as a result of this legislation. However, it is not possible to determine the amount of the fiscal impact, as it would depend entirely on the frequency of usage by the political parties.

The bill becomes effective on July 1, 2025.
