The BDR speaks to minors becoming EMTs. As reviewed, there is no fiscal impact to this portion of the bill at this time. The BDR also speaks to provisional ambulance attendant licenses. Again, as reviewed, there is no fiscal impact to this portion of the bill at this time.

If the population changed to allow for county populations of 100,000, currently that would affect Washoe County, or more to have their own health district, we see this change affecting revenue from an already limited budget by reducing money received for certification and licenses by approximately one-half.

Detailed information is difficult to determine as to how many providers this would affect as a provider may live in one county but work in another county, or they could work in more than one county. Current equations are based on currently known providers affiliated with a permitted agency in Washoe County.

Revenue for permitted agencies and vehicles would go to the new county health district. NRS 450B.200(5).

Funding received by the Program is used to support the software system that tracks and supports education and training of volunteers and firefighters. Grants also support purchase of equipment to rural departments. NRS 450B.1505(1)(2).

Nevada is a member of the United States Emergency Medical Services Compact, NRS 450B.145. The electronic software program ensures compliance with Compact by integrating State data into the National Emergency Medical Services Coordinated Database. All Health agencies in Nevada are required under Nevada Revised Statutes to meet compliance of the Compact regulation which includes use of the same integration software program, statewide.
