### MOTIONS, RESOLUTIONS AND NOTICES

By Assemblymember Anderson:

Assembly Joint Resolution No. 1—Proposing to amend the Nevada Constitution to revise provisions relating to the assessment and taxation of real property which is sold or transferred and to require the Legislature to enact a program to provide property tax assistance to senior citizens and persons with disabilities.

RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That Section 1 of Article 10 of the Nevada Constitution be amended to read as follows:

- Section 1. 1. The Legislature shall provide by law for a uniform and equal rate of assessment and taxation, and shall prescribe such regulations as shall secure a just valuation for taxation of all property, real, personal and possessory, except mines and mining claims, which shall be assessed and taxed only as provided in Section 5 of this Article.
- 2. Shares of stock, bonds, mortgages, notes, bank deposits, book accounts and credits, and securities and choses in action of like character are deemed to represent interest in property already assessed and taxed, either in Nevada or elsewhere, and shall be exempt.
- 3. The Legislature may constitute agricultural and open-space real property having a greater value for another use than that for which it is being used, as a separate class for taxation purposes and may provide a separate uniform plan for appraisal and valuation of such property for assessment purposes. If such plan is provided, the Legislature shall also provide for retroactive assessment for a period of not less than 7 years when agricultural and open-space real property is converted to a higher use conforming to the use for which other nearby property is used.
- 4. Personal property which is moving in interstate commerce through or over the territory of the State of Nevada, or which was consigned to a warehouse, public or private, within the State of Nevada from outside the State of Nevada for storage in transit to a final destination outside the State of Nevada, whether specified when transportation begins or afterward, shall be deemed to have acquired no situs in Nevada for purposes of taxation and shall be exempt from taxation. Such property shall not be deprived of such exemption because while in the warehouse the property is assembled, bound, joined, processed, disassembled, divided, cut, broken in bulk, relabeled or repackaged.
- 5. The Legislature may exempt motor vehicles from the provisions of the tax required by this Section, and in lieu thereof, if such exemption is granted, shall provide for a uniform and equal rate of assessment and taxation of motor vehicles, which rate shall not exceed five cents on one dollar of assessed valuation.
- 6. The Legislature shall provide by law for a progressive reduction in the tax upon business inventories by 20 percent in each year following the adoption of this provision, and after the expiration of the 4th year such inventories are exempt from taxation. The Legislature may exempt any other personal property, including livestock.
  - 7. No inheritance tax shall ever be levied.
- 8. The Legislature may exempt by law property used for municipal, educational, literary, scientific or other charitable purposes, or to encourage the conservation of energy or the substitution of other sources for fossil sources of energy.
- 9. No income tax shall be levied upon the wages or personal income of natural persons. Notwithstanding the foregoing provision, and except as otherwise provided in subsection 1 of this Section, taxes may be levied upon the income or revenue of any business in whatever form it may be conducted for profit in the State.
- 10. The Legislature may provide by law for an abatement of the tax upon or an exemption of part of the assessed value of a single-family residence occupied by the owner to the extent necessary to avoid severe economic hardship to the owner of the residence.
  - 11. For purposes of assessment and taxation of property:
- (a) Except as otherwise provided in this paragraph, for the first fiscal year after the sale or transfer of real property, the real property sold or transferred shall not be eligible for any adjustment provided by the Legislature by law based on the age of improvements to the real property, any abatement of the tax upon the real property provided by the Legislature by law pursuant to subsection 8 or any abatement or exemption provided by the Legislature by law pursuant to subsection 10. The provisions of this paragraph do not apply to real property for which the Legislature has provided by law for an exemption of the tax on property.
- (b) For any fiscal year following the first fiscal year after the sale or transfer of real property to which the provisions of paragraph (a) apply, any adjustment provided by the Legislature by law based on the age of improvements to the real property must be determined as if the improvements were new improvements on the date of the sale or transfer.

- (c) The Legislature shall provide by law for definitions of the terms "sale" and "transfer" as necessary to carry out the provisions of this subsection.
- 12. The Legislature shall provide by law for a program to provide for the payment of refunds of the taxes imposed on the primary residence of a person domiciled in this State who is 62 years of age or older or a person with a disability. If such a person rents his or her primary residence, the amount of the refund for which the person is eligible must not exceed the portion of the rent which is deemed to constitute accrued property tax. The Legislature shall establish by law:
  - (a) The criteria which a person must satisfy to be eligible for such a refund; and
- (b) The amount of the refund to be paid to a person eligible for such a refund, which may consist of a graduated refund based on the household income of such a person.

  And be it further

RESOLVED, That this resolution becomes effective upon passage.

Assemblymember Jauregui moved that the resolution be referred to the Committee on Revenue.

By Assemblymember Kasama:

Assembly Joint Resolution No. 2—Proposing to amend the Nevada Constitution to require that the language of a bill or joint resolution be made available to the public by publication on the Internet website of the Legislature for at least 72 hours before a House may vote on the final passage of the bill or joint resolution.

RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That Section 18 of Article 4 of the Nevada Constitution be amended to read as follows:

- Sec. 18. 1. Every bill, except a bill placed on a consent calendar adopted as provided in subsection 4, must be read by sections on three several days, in each House, unless in case of emergency, two thirds of the House where such bill is pending shall deem it expedient to dispense with this rule. The reading of a bill by sections, on its final passage, shall in no case be dispensed with, and the vote on the final passage of every bill or joint resolution shall be taken by yeas and nays to be entered on the journals of each House. Except as otherwise provided in subsection 2, a majority of all the members elected to each House is necessary to pass every bill or joint resolution, and all bills or joint resolutions so passed, shall be signed by the presiding officers of the respective Houses and by the Secretary of the Senate and Clerk of the Assembly.
- 2. Except as otherwise provided in subsection 3, an affirmative vote of not fewer than two-thirds of the members elected to each House is necessary to pass a bill or joint resolution which creates, generates, or increases any public revenue in any form, including but not limited to taxes, fees, assessments and rates, or changes in the computation bases for taxes, fees, assessments and rates.
- 3. A majority of all of the members elected to each House may refer any measure which creates, generates, or increases any revenue in any form to the people of the State at the next general election, and shall become effective and enforced only if it has been approved by a majority of the votes cast on the measure at such election.
- 4. Each House may provide by rule for the creation of a consent calendar and establish the procedure for the passage of uncontested bills.
- 5. Except as otherwise provided in this subsection, the language of a bill or joint resolution must be made available to the public by publication on the Internet website of the Legislature for at least 72 hours before the House where such bill or joint resolution is pending may vote on the final passage of the bill or joint resolution. The House may only waive such requirement upon request of the Governor for an emergency.

And be it further

RESOLVED, That this resolution becomes effective upon passage.

Assemblymember Jauregui moved that the resolution be referred to the Committee on Legislative Operations and Elections.

By Assemblymember Kasama:

Assembly Joint Resolution No. 3—Proposing to amend the Nevada Constitution to make the Legislature subject to the same provisions of law that are enacted by the Legislature and relate to the inspection and copying of public books and records as any other governmental entity, to require Legislators to disclose certain information regarding entities that receive appropriations in bills, to require the Legislature to publish certain information relating to the personal interests of each Legislator and to make the Legislature subject to the same provisions of law that are enacted by the Legislature and relate to open meetings of public bodies.

RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That a new section, designated Section 40, be added to Article 4 of the Nevada Constitution to read as follows:

Sec. 40. 1. Except as otherwise provided in this section:

- (a) The Legislature and its members are subject to the same provisions of law that are enacted by the Legislature and relate to the inspection and copying of public books and records as any other governmental entity; and
- (b) The Legislature shall provide timely responses to any request for the inspection and copying of a public book or record to the press or any member of the public.
- 2. The following information and records are confidential and not subject to inspection or copying:
- (a) Personnel files;
- (b) Files relating to:
  - (1) Legislative audits;
  - (2) Requests for research performed by legislative staff; and
  - (3) Requests for drafting legislation or administrative regulations;
- (c) Records pertaining to litigation to which the Legislature is a party;
- (d) Information relating to the security and safety of the legislative buildings, grounds or any other legislative property; and
- (e) Records or information, the disclosure of which is exempted or prohibited pursuant to federal or state law.

And be it further

RESOLVED, That a new section, designated Section 41, be added to Article 4 of the Nevada Constitution to read as follows:

- Sec. 41. 1. Each Legislator shall disclose publicly any relationship that the Legislator or a member of the Legislator's immediate family has with any entity that receives an appropriation included in a bill. The information required to be disclosed by a Legislator pursuant to this section includes, without limitation, information relating to employment, contracts, board affiliation and any other direct relationship between an entity and the Legislator or a member of the Legislator's immediate family.
- 2. The Legislature shall publish regularly a list of conflict disclosures that, for each Legislator, identifies all personal interests of the Legislator that may result in a conflict of interest.

And be it further

RESOLVED, That Section 6 of Article 4 of the Nevada Constitution be amended to read as follows:

[See:] Sec. 6. [Each] Except as otherwise provided in this Constitution, each House shall judge of the qualifications, elections and returns of its own members, choose its own officers (except the President of the Senate), determine the rules of its proceedings and may

punish its members for disorderly conduct, and with the concurrence of two thirds of all the members elected, expel a member.

And be it further

RESOLVED, That Section 15 of Article 4 of the Nevada Constitution be amended to read as follows:

- Sec. 15. *I*. The doors of each House shall be kept open during its session, and neither shall, without the consent of the other, adjourn for more than three days nor to any other place than that in which they may be holding their sessions.
- 2. The meetings of all legislative committees must be open to the public, except meetings held to consider the character, alleged misconduct, professional competence, or physical or mental health of a person.
- 3. The Legislature and its members are subject to the same provisions of law that are enacted by the Legislature and relate to open meetings of public bodies.

And be it further

RESOLVED, That this resolution becomes effective upon passage.

Assemblymember Jauregui moved that the resolution be referred to the Committee on Legislative Operations and Elections.

Motion carried.

By Assemblymember Kasama:

Assembly Joint Resolution No. 4—Proposing to amend the Nevada Constitution to prohibit appropriations to any political organization, to prohibit including an appropriation to a nonprofit organization in any bill that is required to fund a portion of the state budget for the next ensuing biennium and to authorize the Governor to veto appropriations in a bill.

RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That Section 19 of Article 4 of the Nevada Constitution be amended to read as follows:

[Section] Sec. 19. 1. No money shall be drawn from the treasury but in consequence of appropriations made by law.

- 2. No money shall be drawn from the treasury pursuant to subsection 1 for the purpose of making by law an appropriation to any political organization, including, without limitation, a political party or a committee for political action.
- 3. No appropriation made to a nonprofit organization may be included in any bill that is required to fund a portion of the state budget for the next ensuing biennium.
- 4. As used in this section, "biennium" means a period of 2 fiscal years beginning on July 1 of an odd-numbered year and ending on June 30 of the next ensuing odd-numbered year.

And be it further

RESOLVED, That Section 35 of Article 4 of the Nevada Constitution be amended to read as follows:

[See:] Sec. 35. 1. Every bill which may have passed the Legislature, shall, before it becomes a law be presented to the Governor. If he approve it, he shall sign it, but if not he shall return it with his objections, to the House in which it originated, which House shall cause such objections to be entered upon its journal, and proceed to reconsider it; If after such reconsideration it again pass both Houses by yeas and nays, by a vote of two thirds of the members elected to each House it shall become a law notwithstanding the Governors objections. [Iff Except as otherwise provided in this section, if any bill shall not be returned within five days after it shall have been presented to him (Sunday excepted) exclusive of the day on which he received it, the same shall be a law, in like manner as if he had signed it, unless the Legislature by its final adjournment, prevent such return, in which case it shall be a law, unless the Governor within ten days next after the adjournment (Sundays excepted) shall file such bill with his objections thereto, in the office of the Secretary of State, who shall lay the same before the Legislature at its next Session, in like manner as if it had been

returned by the Governor, and if the same shall receive the vote of two-thirds of the members elected to each branch of the Legislature, upon a vote taken by yeas and nays to be entered upon the journals of each house, it shall become a law.

- 2. If any bill so presented to the Governor contains one or more appropriations of money from the State Treasury, the Governor may strike from the bill any or all of these appropriations without objecting to the bill as a whole. If the Governor strikes out one or more appropriations, the Governor shall, within 48 hours after the bill is presented to the Governor:
- (a) Attach to the bill a statement of the appropriations stricken out and the reasons for the striking out; and
  - (b) Transmit a copy of the statement to:
- (1) If the Legislature has not adjourned sine die, the House in which the bill originated; or
- (2) If the Legislature has adjourned sine die, the Secretary of State who shall lay the same before the Legislature at its next Session.
- 3. Each appropriation not stricken out becomes law in the same manner as a bill to which the Governor does not object. If the Governor fails to transmit a copy of the statement pursuant to subsection 2 within 48 hours after the bill is presented to the Governor, each appropriation stricken out likewise becomes law.
- 4. The Legislature may, by the same vote as for bills to which the Governor objects, cause any one or more of the individual appropriations stricken by the Governor to become law, notwithstanding the Governor striking it out. If the Legislature does not so act, any appropriation stricken from the bill by the Governor shall be deemed not appropriated.

And be it further

RESOLVED, That this resolution becomes effective upon passage.

Assemblymember Jauregui moved that the resolution be referred to the Committee on Legislative Operations and Elections.

By Assemblymember Kasama:

Assembly Joint Resolution No. 5—Proposing to amend the Nevada Constitution to make the Legislature subject, when establishing or revising boundaries of any legislative district, to the same provisions of law that are enacted by the Legislature and relate to the inspection and copying of public books and records as any other governmental entity and to make the Legislature subject to the same provisions of law that are enacted by the Legislature and relate to open meetings of public bodies.

RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That Section 5 of Article 4 of the Nevada Constitution be amended to read as follows:

- Sec. 5. 1. Senators and members of the Assembly shall be duly qualified electors in the respective counties and districts which they represent, and the number of Senators shall not be less than one-third nor more than one-half of that of the members of the Assembly.
- 2. It shall be the mandatory duty of the Legislature at its first session after the taking of the decennial census of the United States in the year 1950, and after each subsequent decennial census, to fix by law the number of Senators and Assemblymen, and apportion them among the several counties of the State, or among legislative districts which may be established by law, according to the number of inhabitants in them, respectively.
- 3. When establishing or revising the boundaries of any legislative district pursuant to subsection 2, the Legislature and its members are subject to the same provisions of law that are enacted by the Legislature and relate to:
  - (a) Open meetings of public bodies; and

(b) The inspection and copying of public books and records as any other governmental entity.

And be it further

RESOLVED, That Section 6 of Article 4 of the Nevada Constitution be amended to read as follows:

[See:] Sec. 6. [Each] Except as otherwise provided in this Constitution, each House shall judge of the qualifications, elections and returns of its own members, choose its own officers (except the President of the Senate), determine the rules of its proceedings and may punish its members for disorderly conduct, and with the concurrence of two thirds of all the members elected, expel a member.

And be it further

RESOLVED, That this resolution becomes effective upon passage.

Assemblymember Jauregui moved that the resolution be referred to the Committee on Legislative Operations and Elections.

By Assemblymember Miller:

Assembly Joint Resolution No. 6—Urging Congress to extend the Social Security Fairness Act.

Assemblymember Jauregui moved that the resolution be referred to the Committee on Legislative Operations and Elections.

By Assemblymembers Watts, Mosca and Hibbetts; Senators Nguyen and Stone:

Assembly Joint Resolution No. 7—Proposing to amend the Nevada Constitution to provide a citizens' commission to establish the compensation of certain elected officers.

RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That a new section, designated Section 33A, be added to Article 4 of the Nevada Constitution to read as follows:

- Sec. 33A. 1. The Legislature shall provide by law for a Citizens' Commission on Compensation for Certain Elected Officers.
- 2. The Commission must consist of seven members appointed by the Governor who have diverse personal and professional interests and reside in various geographical areas of this State, who must include:
- (a) One member who has expertise in public compensation and is recommended by the Public Employees' Retirement Board or its successor organization;
  - (b) One member who represents a nonprofit public interest organization;
  - (c) One member who represents the general public;
  - (d) Two members who represent the interests of business in this State; and
- (e) Two members who have experience as officers or members of a labor organization in this State and are recommended by a labor organization in this State.
- 3. Each member of the Commission must be a resident of this State and must not be a state officer, public employee or lobbyist, or a parent, spouse, sibling, child or dependent of a state officer, public employee or lobbyist.
- 4. Except as otherwise provided in this subsection, the term of office of each member of the Commission is 4 years. The Governor shall appoint three of the members first appointed by him or her for initial terms of 2 years. If a vacancy occurs, the Governor shall fill the vacancy for the unexpired term in the same manner as the original appointment within 30 days after the vacancy occurs. A member of the Commission may not serve more than two terms.

- 5. The Governor may remove a member of the Commission only for cause of incapacity, incompetence, neglect of duty, malfeasance in office or failure to meet a qualification set forth in subsections 2 and 3.
- 6. The Commission shall elect a Chair from among its members. Except as otherwise provided in this section, the Commission shall adopt rules of procedure for the conduct of its hearings and any other procedural rules it deems necessary to carry out its duties. The affirmative vote of a majority of all the members appointed to the Commission is required to take action.
  - 7. Members of the Commission are entitled to:
- (a) The compensation provided by law for members of the Commission on Judicial Discipline who are not judicial officers; and
- (b) The per diem allowance and travel expenses provided by law for state officers and employees generally.
  - 8. The Commission shall:
- (a) Study the relationship of salaries and benefits to the duties of the members of the Legislature, the Governor, Lieutenant Governor, Secretary of State, State Treasurer, State Controller and Attorney General;
- (b) Compare the salaries and benefits of the elected officers set forth in paragraph (a) to the salaries and benefits of persons who are employed by a public or private employer and who have similar qualifications and responsibilities as those elected officers;
  - (c) Fix the salaries and benefits of the elected officers set forth in paragraph (a); and
  - (d) Carry out any duties provided by law by the Legislature.
- 9. Except for the initial schedule of salaries and benefits for elected officers filed pursuant to subsection 10, the Commission may not increase or decrease the salary of any elected officer set forth in paragraph (a) of subsection 8 by more than 15 percent of the salary of that elected officer provided in the immediately preceding schedule of salaries for elected officers. The Commission may exercise any powers conferred by the Legislature.
- 10. The Commission shall file its initial schedule of salaries and benefits for elected officers with the Secretary of State not later than January 1, 2029, and shall file a schedule of salaries and benefits not later than January 1 of each odd-numbered year thereafter. Each schedule of salaries and benefits is effective:
- (a) For members of the Legislature, for the period from the first Monday of February immediately following the January 1 that the schedule is due through the day before the first Monday of February of the next odd-numbered year; and
- (b) For all other elected officers set forth in paragraph (a) of subsection 8, for the period from July 1 immediately following the January 1 that the schedule is due through June 30 of the next odd-numbered year.
- 11. The Legislature shall provide by law for setting apart from each year's revenues a sufficient amount of money to pay such salaries and benefits.
- 12. Before the Commission may file a schedule of salaries and benefits with the Secretary of State, the Commission shall hold at least four meetings to receive public testimony on the schedule. At the last public hearing before the schedule is filed with the Secretary of State, the Commission shall adopt the schedule as originally proposed or as amended. All meetings of the Commission are subject to the provisions of any open meeting laws made applicable generally to other public bodies.
- 13. The Legislative Counsel Bureau shall include in the Nevada Revised Statutes a copy of the most recent schedule of salaries and benefits established by the Commission and filed with the Secretary of State.

And be it further

RESOLVED, That Section 33 of Article 4 of the Nevada Constitution be amended to read as follows:

Sec. 33. The members of the Legislature shall receive for their services a compensation to be fixed by <code>[law]</code> the Citizens' Commission on Compensation for Certain Elected Officers pursuant to Section 33A of this Article and paid out of the public treasury, for <code>[not to exceed 60 days]</code> each calendar day of service during any regular session of the Legislature

and [not to exceed 20 days] during any special session [; but no increase of such compensation shall take effect during the term for which the members of either house shall have been elected; Provided, that an]. The Citizens' Commission on Compensation for Certain Elected Officers may provide for the compensation of members of the Legislature for the performance of duties as a member of the Legislature outside of a regular or special session. An appropriation may be made for the payment of such actual expenses as members of the Legislature may incur for postage, express charges, newspapers and stationery not exceeding the sum of Sixty dollars for any general or special session to each member; and Furthermore Provided, that the Speaker of the Assembly, and Lieutenant Governor, as President of the Senate, shall each, during the time of their actual attendance as such presiding officers receive an additional allowance of two dollars per diem.

RESOLVED, That Section 9 of Article 15 of the Nevada Constitution is hereby repealed. And be it further

RESOLVED, That this resolution becomes effective upon passage.

#### TEXT OF REPEALED SECTION

Sec: 9. Increase or decrease of compensation of officers whose compensation fixed by constitution. The Legislature may, at any time, provide by law for increasing or diminishing the salaries or compensation of any of the Officers, whose salaries or compensation is fixed in this Constitution; Provided, no such change of Salary or compensation shall apply to any Officer during the term for which he may have been elected.

Assemblymember Jauregui moved that the resolution be referred to the Committee on Legislative Operations and Elections.

By the Committee on Judiciary:

Assembly Bill No. 3—AN ACT relating to civil actions; increasing the monetary threshold for mandatory nonbinding arbitration in civil actions; and providing other matters properly relating thereto.

Assemblymember Jauregui moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By the Committee on Judiciary:

Assembly Bill No. 4—AN ACT relating to offenders; authorizing the Division of Parole and Probation of the Department of Public Safety to petition the sentencing court or the State Board of Parole Commissioners for the release of a person sentenced to lifetime supervision; authorizing the sentencing court or Board to grant such a petition under certain circumstances; clarifying provisions relating to certain allowable deductions from the period of probation of certain offenders; and providing other matters properly relating thereto.

Assemblymember Jauregui moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By the Committee on Commerce and Labor:

Assembly Bill No. 216—AN ACT relating to domestic violence; requiring a peace officer who investigates an act of domestic violence to conduct a lethality assessment under certain circumstances; requiring a peace officer who conducts a lethality assessment to take certain actions based upon the results of the assessment; requiring the Director of the Department of Public Safety to prescribe the form on which the results of a lethality assessment must be reported to the Department; requiring the Department to provide certain supportive services and develop certain training relating to lethality assessments; requiring the Administrative Office of the Courts to make the training concerning lethality assessments available to certain persons; requiring certain written reports prepared by a peace officer who investigates an act of domestic violence to include the results of a lethality assessment; authorizing a court to consider the results of a lethality assessment in reviewing the custody status of certain persons; and providing other matters properly relating thereto.

Assembly Bill No. 217—AN ACT relating to education; prohibiting school districts, public schools and their employees from providing permission to

access school district facilities to certain federal officials investigating or enforcing immigration laws; prohibiting school districts, public schools and their employees from providing information concerning pupils to certain federal, state or local officials investigating or enforcing immigration laws; prohibiting a school police officer or employee of certain school districts from using a chemical agent or electronic stun device against pupils or minors in certain settings; requiring certain entities to prepare and submit a report to the board of trustees of a school district after such prohibited instruments are used; requiring the board of trustees of the school district to conduct an investigation and make certain determinations after receiving such a report; providing penalties; and providing other matters properly relating thereto.

Assemblymember Jauregui moved that the bill be referred to the Committee on Education.

Assembly Bill No. 218—AN ACT relating to courts; requiring the Court Administrator and each court in this State to establish a program to send certain communications regarding court proceedings by text message; requiring the Court Administrator to convene a working group to study the programs among other duties; requiring the Court Administrator to prepare and submit an annual report regarding the programs; requiring children taken into custody and persons issued certain citations or arrested to provide a telephone number for purposes of receiving certain communications by text message; and providing other matters properly relating thereto.

Assembly Bill No. 220—AN ACT relating to identification cards; authorizing the Department of Health and Human Services to establish a program to issue identification cards to Nevada residents who are experiencing homelessness; requiring an applicant for an identification card to attest to certain facts and provide certain information providing for the change of the full legal name on an identification card under certain circumstances; providing for the expiration of an identification card issued by the Department; prohibiting certain conduct related to an identification card; authorizing certain

local governments to accept an identification card issued by the Department for certain purposes; providing penalties; and providing other matters properly relating thereto.
