Senate Concurrent Resolution No. 1.

WHEREAS, Born 2 months premature at a mere 4 pounds in Reno, Nevada in 1957, Kathleen "Neena" Laxalt entered the world with an indomitable fighting spirit; and

WHEREAS, The devoted daughter of parents Paul Dominique Laxalt and Jackalyn Ross Laxalt, Neena Laxalt grew up in Carson City with her five siblings and many cousins; and

WHEREAS, Neena Laxalt was raised in the world of law and politics with her maternal grandfather, Judge John R. Ross, serving as a federal judge for the U.S. District Court for the District of Nevada from 1954 to 1963 and her father, Paul D. Laxalt, serving as Nevada's Lieutenant Governor, Governor and U.S. Senator between 1963 and 1987; and

WHEREAS, A proud product of humble immigrants who settled in Nevada, Neena Laxalt, as a fourth-generation Irish descendant, possessed a keen sense of humor, a refined gift of conversation and, as a second-generation Basque descendant, a clear focus and unfailing work ethic; and

WHEREAS, After beginning her storied lobbying career in the halls of the Arizona Legislature, Neena Laxalt spent over 25 years skillfully navigating the legislative process at the Nevada Legislature and in other governmental arenas by providing valuable insights and fostering collaboration among policymakers, stakeholders and communities; and

WHEREAS, In 2017, her colleagues recognized her significant contributions by inducting her into the Nevada Legislature's James A. Joyce Lobbyist Hall of Fame; and

WHEREAS, Neena Laxalt has had a marked impact on numerous state policies, notably in the areas of agriculture, ranching, animal welfare and the well-being of Nevada's Native American and rural communities, and she devoted innumerable hours in her leadership role planning the historic celebration of Nevada's sesquicentennial anniversary; and

WHEREAS, Neena Laxalt mentored countless young professionals, especially women, and her guidance and support empowered them to flourish in their advocacy or political careers; and

WHEREAS, An animal and nature enthusiast, Neena Laxalt became the guardian of the revered Laxalt family sheep camp at Marlette Lake, following in her Basque grandfather Dominique Laxalt's footsteps; now, therefore, be it

RESOLVED BY THE SENATE OF THE STATE OF NEVADA, THE ASSEMBLY CONCURRING, That the members of the Nevada Legislature offer their deepest condolences to Neena Laxalt's daughter, Kevan Danielle, her granddaughter, Grace Kathleen, her four siblings, her many cousins and her many lifelong friends; and be it further

RESOLVED, That the legacy of Neena Laxalt's distinguished lobbying career and service to this State will long be remembered and serve as an inspiration to others to embrace the role of mentor or tireless advocate for their causes; and be it further

RESOLVED, That the Secretary of the Senate prepare and transmit a copy of this resolution to the family of Neena Laxalt; and be it further

RESOLVED, That this resolution becomes effective upon adoption.

Remarks by Assemblymembers Anderson, Monroe-Moreno, and Mr. Speaker.

ASSEMBLYMEMBER ANDERSON:

Neena Laxalt was a friend of mine and although we did not always agree with each other, we were able to disagree in a way that showed that we had a shared love of Nevada. One thing, or many things, about Neena: she loved a good joke, that laugh, those of us that know that laugh, and she was quick with it—oh my gosh, so quick with that laugh. The other thing that was quick was her temper. I think that shows her Basque and Irish background and her ability to have a long memory. She would remember something that happened 10 years ago and be like, "Wait, wait, wait, you did this." And you are just thinking that was a random Wednesday, but okay.

One of the strongest things about Neena that was mentioned, and I think one reason why some people are so emotional about this today, is she took interns, and she took other females that were not always as welcome in these halls as they are today. She took them under her wing, and she would show us the ropes, and she would tell us even if you are not in agreement with me, this is how you get things done. She respected and loved these halls, both our house and the other house, because she recognized that this is where Nevadans came in to talk with each other. She loved

that, and she protected it, and she celebrated it. The other thing that she celebrated was her love of Marlette Lake and Nevada, and I think that her dedication to this area continues to serve as an inspiration to all of us. Finally, as one of her friends stated, although she is no longer with us, her spirit and belief in us will continue to live on.

ASSEMBLYMEMBER MONROE-MORENO:

I rise today in honor of a remarkable woman that graced hallways and I was able to call friend, Neena Laxalt. Her willingness to work with anyone for the betterment of Nevada was a memorable attribute that she had. Neena was unique and always had a different insight on issues and she often did that through humor. Like she did with so many in our state, she took me under her wing. Before I was even a freshman legislator, we had a chance meeting at a social event—and if you have ever been in Neena's car, it smells of tobacco and it is definitely a mobile office—but at that event, we talked and we realized we were not on the same side of the political lines, but we were aligned on so many things about making Nevada a better place to live in. And on that night, we became friends.

When she called me and let me know that she had had a diagnosis, I tried to remain strong during that call for her while selfishly crying inside because I knew that we were going to lose someone that understands what it means to serve Nevadans and to work across political aisles to make sure that we build friendships, have conversations, have dialogues, even when we do not get along, that was Neena. When I learned of her passing, I cried again because I knew we had freshmen legislators that would never have that opportunity to meet this amazing woman.

For her family, she was honest, to a fault, even when it hurt and she, like me, believed: tell me the truth, even if it hurts because I will respect you for doing that. These halls will be empty without Neena. I will miss her. Our thoughts and our prayers are with her family and her friends and for all the legislators that she has mentored over the years. I feel very fortunate and blessed to have known her, to have been able to call her one of my mentors, and a friend.

Mr. Speaker requested the privilege of the Chair for the purpose of making the following remarks:

SPEAKER YEAGER:

I want to thank the family for sharing Neena with us. Many of you know I lobbied in this building in the 2013 and 2015 Sessions, and it probably is an understatement to say that I had no idea what I was doing. It was hard to know who to trust, but Neena very quickly became somebody who I could trust, to tell it like it was, to always speak her mind, and to be on the right side of issues. I just want to echo that I did not get personally mentored by Neena, but she was a force in this building and her moral compass was just extraordinarily strong to stand up for causes and people that she believed in.

I think her legacy, of course, is demonstrated by everyone still in this building, whether they are lobbyists, whether they are legislators, whether they are staff members, everybody that she touched by the way that she conducted herself. So, while it is certainly a sad day because we have lost her, her legacy is going to live on and lives on in this building as we speak. I just wanted to express that I really appreciate her for who she was as a person and for always looking out for other people. There are certainly lessons there that we can all take in our own lives and just want to remember her for the extraordinary, extraordinary Nevadan that she was.
