INTRODUCTION, FIRST READING AND REFERENCE

Assembly Bill No. 263—AN ACT relating to homelessness; requiring the board of county commissioners of certain counties to establish homeless outreach teams; establishing the duties of each homeless outreach team; and providing other matters properly relating thereto.

Assemblymember Nguyen moved that the bill be referred to the Committee on Government Affairs.

Assembly Bill No. 264—AN ACT relating to professional licensing; establishing procedures by which an applicant for a professional or occupational license may obtain judicial review of the decision of a licensing agency denying the application of the applicant on the basis of the moral character or criminal history of the applicant; and providing other matters properly relating thereto.

Assemblymember Nguyen moved that the bill be referred to the Committee on Government Affairs.

Assembly Bill No. 265—AN ACT relating to water; requiring the Division of Water Resources of the State Department of Conservation and Water Resources to notify an applicant if a committee is assigned to review certain applications for a permit; providing certain deadlines for the State Engineer to approve or deny certain applications and extensions, review reports of conveyance and issue certain permits; requiring the State Engineer to provide certain notices relating to the cancellation of a permit; and providing other matters properly relating thereto.

Assembly Bill No. 266—AN ACT relating to public health; requiring the Department of Health and Human Services to publish certain information relating to breastfeeding and develop a program of public education concerning lactation; authorizing certain providers of health care and medical facilities to provide that information to certain persons; prohibiting a place of public accommodation from engaging in certain discrimination against a person who is breastfeeding; authorizing certain civil actions and administrative actions to enforce that prohibition; providing a penalty; and providing other matters properly relating thereto.

Assembly Bill No. 268—AN ACT making an appropriation to the State Department of Agriculture for the purpose of awarding grants of money to Nevada school districts to provide universal free breakfast and lunch for Nevada pupils; and providing other matters properly relating thereto.

Assembly Bill No. 271—AN ACT relating to elections; prohibiting the use of artificial intelligence in equipment used for voting, ballot processing or ballot counting; requiring certain published material that is generated through the use of artificial intelligence or that includes a materially deceptive depiction of a candidate to include certain disclosures; prohibiting, with certain

exceptions, the distribution of synthetic media that contains a deceptive and fraudulent deepfake of a candidate; providing penalties; and providing other matters properly relating thereto.

Assemblymember Mosca moved that the bill be referred to the Committee on Legislative Operations and Elections.

Assembly Bill No. 272—AN ACT relating to forensic medical examinations; repealing, replacing and revising certain provisions relating to the payment of and reimbursement for forensic medical examinations of certain victims of crime; and providing other matters properly relating thereto.
